E. City Manager's Report:

1) With regard to the contract between the City of Shelby and the North Carolina Department of Transportation (NCDOT) for the mowing of US Highway 74 inside the corporate limits, Mr. Howell informed Council the City had been reimbursed \$20,000 per year for those services. The NCDOT has proposed to reduce the contract reimbursement by \$5,000. He recommended the City not renew this agreement for the reduced contract amount of \$15,000 at this time.

- 2) Mr. Howell reported that Human Resources Director Deb Jolly and Energy Services Director Julie McMurry have been in discussions with Cleveland Community College in an effort to develop and offer an electric lineman training program for the purpose of future employment recruitment of this skilled trade.
- 3) Mr. Howell advised Council to anticipate and to expect extensive construction activities to take place in the spring 2017 in the Uptown Shelby alleys, including those along Campbell Street, Dale Street, and Arey Street from Lafayette Street to Morgan Street. Some of the work will be completed in conjunction with the continuation of the next phase of the Parking Lot Improvements Project.
- 4) Mr. Howell provided an update regarding the City's application to the Building Reuse Community Development Block Grant Program through the North Carolina Department of Commerce for two projects, the Campbell Building and the Sterchi Building. Although preliminary approval for \$500,000 has been granted, final approval is taking longer than anticipated due to the newness of the funding program and its administration.
- 5) Mr. Howell reminded Council to save the date of December 13, 2016 at 11:00 a.m. for Huesker, Inc.'s inauguration celebration at its manufacturing plant located at 1901 West Dixon Boulevard in Shelby, North Carolina.

1) Mr. Causby expressed his appreciation to Mr. Howell for his recent City Manager update which was provided last week.
