#### City Manager's Recommendation / Comments

The grant noted above provided \$3,000,000 in funding to be used toward the \$7,100,000 sewer project. This project included the addition of approximately 20,600 linear feet of 24" diameter gravity sewer line, improvements to the Crest Sewer Lift Station, installation of approximately 12,000 linear feet of sewer force main. It was installed to provide capacity in the system to serve Clearwater Paper which committed to investing \$330,000,000 and creating 180 jobs. They have fulfilled this commitment as required by the economic development incentive agreement and are well on their way to being in production. The purpose of this hearing is to allow public comment on this matter.

Mayor Anthony called the meeting to order at 6:00 p.m. and welcomed all who were in attendance. The Mayor gave the invocation and Mr. Amaya led the *Pledge of Allegiance*.

#### A. Approval of agenda:

ACTION TAKEN: Upon a motion made by Mr. Amaya, City Council voted unanimously to approve the agenda as presented.

#### **B. Special Presentations:**

1) Certified Entrepreneurial Community (CEC) Program update – Steve Padgett, Director, Small Business Center, Cleveland Community College

Mr. Padgett is reporting to all 15 municipalities in Cleveland County and expressing his appreciation for their support of and participation in this program. He reminded all in attendance the Certified Entrepreneurial Community Program celebrated its second anniversary in December 2018.

Mr. Padgett stated the program is alive and well and conducting a great deal of activity particularly through referrals. At the Small Business Center, these referrals come through a wide variety of sources demonstrating the program

is well known throughout Cleveland County and the community is sharing the information.

Mr. Padgett announced through a collaborative project with the Isothermal Planning and Development Commission (IPDC), Mountain BizWorks, a regional small business development organization, based in Asheville, North Carolina, will open a pop-up office in Shelby. Mountain BizWorks is a non-profit which will provide their services of coaching, educating, and financing to start-up businesses as well as existing businesses in this area. The Mountain BizWorks office will be opened from April through May 2019 to serve Cleveland County.

Next, Mr. Padgett envisions the CEC program allowing Cleveland County to develop as an entrepreneurial magnet in which small business owners and aspiring entrepreneurs have access to resources needed to make their dreams a reality. He foresees this region where collaboration, creativity, innovation, and investment generate opportunity and prosperity for all.

Mr. Padgett concluded by expressing his appreciation to City Council and to Mr. Howell for their continued support and enthusiasm for the CEC Program.

Council received the information. No action was required.

2) Beating Recycle Contamination - Danny Darst, Director of Public Works

Mr. Darst begin his presentation by sharing statistical information relating to Shelby's Curbside Rollout Recycling Program. Since the program began in January 2012 to the present, recycling tonnage has steadily increased and in 2018 to more than 1,063 tons with an annual average of 88.66 tons per month. Mr. Darst noted the program has become very successful among residents, stating residential participation is at 77 percent and commercial participation is at 40 percent.

Mr. Darst explained contamination in the recycling industry has become a major problem worldwide. The first signs of trouble came in January 2018 when China banned the importation of several categories of recyclable waste. For decades, China had bought massive shipments of recyclable plastics, paper, cardboard, and other materials from countries around the world. China abruptly announced its intention to close it borders to this trash influx. The country banned the import of 24 categories of solid waste, including several kinds of scrap plastic and mixed paper. It also demanded that other waste materials, like cardboard and scrap metal, have only a very minimal percentage of contamination from food and other sources. Mr. Darst stated this has caused the recycle industry to restrict the product delivered to the transfer stations. These transfer stations are rejecting contaminated

loads and are asking for assistance to clean up the recycle stream. Mr. Darst further stated Recycle Shelby and Republic Services will be checking recycling carts for contamination. When carts are identified as contaminated, the newly designed City's tag and flyer to re-educate the customer, stating what can and cannot be recycled, will be attached to the cart. The contaminated materials must be removed and placed in the refuse cart.

Mr. Darst summarized several talking points and stressed that contamination is a reality but data and experience prove that the public can reduce it through consistent and sustained education and improvements in sorting technology. Education is the way to help encourage best practices and refine the public's sorting skills for the reason that recycling is still the right thing to do.

Council received the information. No action was required.

#### F. Unfinished Business:

1) City of Shelby's W-5712A NC 180 and SR 2202 Water and Sewer Utility Relocation Project

Mr. Howell introduced Ordinance No. 25-2019 for Council's consideration. If approved, this ordinance would appropriate funding for the relocation of the City owned water distribution and sewer collection lines in and around the intersection of Joe's Lake Road and South Post Road in the southeastern

section of the City. The North Carolina Department of Transportation (NCDOT) has funded and is building a roundabout at this intersection. As such, the City is being required by NCDOT to relocate all of its utility infrastructure to accommodate the road work. This ordinance only affects the water and sewer systems. The work is estimated to cost \$232,711 and the City's share is \$90,052.75. The City will agree to allow NCDOT to include approved work within their construction contract. NCDOT will pay these costs up front and the City will reimburse its portion of the total cost once billed by NCDOT. The City's share is appropriated from the Water Fund and Sewer Fund capital reserves, respectively. Mr. Howell noted \$42,500.00 represents sewer location costs for a private force main sewer owned by Ingles Market. The City will seek reimbursement of those costs, however, no prior agreement exists between the City and Ingles.

Next, Mr. Howell introduced Resolution No 24-2019 for Council's consideration. The resolution authorizes the City to enter into a Utility Construction Agreement associated with Project W-5712A.

2) City of Shelby's U-5775 NC 150 and US 74 Business Water and Sewer Utility Relocation Project:

Mr. Howell introduced Ordinance No. 26-2019 for Council's consideration. If approved, this ordinance would appropriate funding for the relocation of the City owned water distribution and sewer collection lines in and around the intersection of East Marion Street, Cherryville Road, and Peach Street. The North Carolina Department of Transportation (NCDOT) has funded and is realigning these intersections. As such, the City is being required by NCDOT to relocate all of its utility infrastructure to accommodate the road work. The ordinance only affects the water and sewer systems and the City's share is \$271,465.25. Under North Carolina General Statutes, the City is responsible for 25 percent of relocation costs and 100 percent of any betterment costs. With the relocation of the intersection, the City has elected to upsize the waterlines on Peach Street, Marion Street, and Cherryville Road in efforts to provide eventual looping of the distribution system in a long-term effort to increase flow distribution to East and Northeast Shelby. The City will agree to allow NCDOT to include approved work within their construction contract. NCDOT will pay these costs up front and the City will reimburse its portion of the total cost once billed by NCDOT. The City's share is appropriated from the Water Fund and Sewer Fund capital reserves, respectively. Mr. Howell noted this project was accelerated by NCDOT after the City agreed to provide \$300,000 towards construction several years ago.

Next, Mr. Howell introduced Resolution No 25-2019 for Council's consideration. The resolution authorizes the City to enter into a Utility Construction Agreement associated with Project U-5775.

  - 2) Mr. Howell informed Council that the Bank of the Ozarks has applied to the Cleveland County Historic Preservation Commission for designation as a local historic landmark.
  - 3) Mr. Howell mentioned the transfer of \$500,000 from the North Carolina Division of Aviation equates to \$450,000 of additional federal funds and a \$50,000 local match which will be utilized for the construction of a third 10-unit T-Hangar building at the Shelby-Cleveland County Regional Airport as approved. The City is now able to experience a significant reduction in construction costs compared to constructing this hangar as a separate project in the future. It was noted that all expenses related to this project are eligible for 90 percent Non-Primary Entitlement (NPE) grant funding via either existing grants or future annual NPE grants.
  - 4) Mr. Howell reminded Council the opening of Hanna Park and all related ceremonies and activities is set for March 30, 2019 at 10:00 a.m., 1655 McBrayer Springs Road.



#### City Manager's Recommendation / Comments

Resolution No. 26-2019 is presented for City Council consideration at this time via the Consent Agenda. If approved this resolution would award a contract in the amount of \$42,240 to Cleveland Contractors for the construction of stormwater system improvements at 203 Montrose Circle. This project qualifies for assistance through the City's stormwater infrastructure assistance program which allows the City to share costs with a private property owner under certain circumstances spelled out in policy. The City will shoulder 80% of this project with the property owner paying 20%. The City's portion of this project is paid through revenue generated from existing stormwater fees.

It is recommended that Resolution No. 26-2019 be adopted and approved via the Consent Agenda.

#### Background

As detailed in the attached memorandum from Tyler Brooks,
Stormwater/Engineering Technician, the City received an application for
Stormwater Infrastructure Assistance outside of the public right-of-way at 203
Montrose Circle. The issue at this location is two sinkholes in the yard that have
been a recurring problem that the owner has made the City aware of several times in
recent years. It is also important to note that the stormwater system crossing this
property ties directly to the culvert under Montrose Circle and ends at the creek on
the lower end of this same property.

City staff reviewed the condition of the infrastructure at this location with Odom Engineering, PLLC and determined that the solution was to replace the failing 24" pipe crossing this property. This project was bid and Odom Engineering recommends award of the construction contract to the lowest responsive bidder, Cleveland Contractors, Inc., in the amount of \$42,240.00. As a reminder, the Stormwater Infrastructure Assistance Policy (Resolution No. 3-2016) states that the City will be responsible for 80% of the construction cost and the private property owner will be responsible for the remaining 20% via a legal agreement. Further, the property owner will be responsible for ensuring that the improved stormwater system is properly maintained for a period of 5 years after completion of construction.

#### Recommendation

City Staff recommends that the Shelby City Council approve the resolution awarding the bid for the Stormwater Infrastructure Assistance Program project located at 203 Montrose Circle to the lowest responsive bidder, Cleveland Contractors, Inc. for the bid price of \$42,240.00. The City will be responsible for 80% of this bid amount

(\$33,792.00) and the property owner will be responsible for 20% (\$8,448.00). Funding for the City's portion of this construction contract is available in the existing Stormwater Utility budget.

#### **Background**

In February 2016, the City of Shelby implemented a Stormwater Infrastructure Assistance Program to assist property owners with the costs of repairing and/or replacing stormwater infrastructure causing stormwater issues on their private property. Per City ordinance, the City does not have maintenance responsibilities outside of the public rights-of-way. Funding for such projects in excess of \$10,000 shall be presented to the Shelby City Council for consideration before awarding contracts.

#### Review

In December 2018, the property owners at 203 Montrose Circle applied for Stormwater Infrastructure Assistance to address failing stormwater infrastructure on the property. The owner reported that two sinkholes were forming in the yard. After evaluating the current stormwater system on the property, it was determined that the 24"metal pipe conveying runoff through the property was failing. As a result of the failing pipe, water is backing up into the City stormwater system.

In January 2019 agreements were signed between the City and Owners, and a third party consultant was asked to provide a design for replacing the infrastructure on the property. The plans call for the failing pipe to be filled with concrete and a new pipe laid through the property. Bids were electronically submitted on March 12, 2019. At that time contractors were notified that costs had to be approved by the property owner and City Council before starting construction. The low bidder for this project is Cleveland Contractors Inc. with a bid of \$38,400.00 with \$3,840.00 in contingency for a total project bid of \$42,240.00. The property owners desire to proceed with the project.


#### Recommendation

These agreements and undertakings are in consideration of the sums agreed to be paid for such work by the OWNER(S), the benefit therefrom according to the public, and the mutual terms and conditions set forth below.
The CITY as specified in Resolution No.3-2016, will perform or contract for improvements as indicated in plans developed by the CITY for the infrastructure improvement project described below:  Replace degraded stormwater infrastructure on the property that is causing a sinkhole at the driveway.
WHEREAS, the Common Law Doctrine known as the "rule of reasonable use" which has been formally adopted by the North Carolina Supreme Court with respect to surface water drainage allows reasonable alteration of the flow of storm water runoff which may cause harm to properties; and
WHEREAS, there are locations throughout the City of Shelby where the altered flow of storm water runoff

through private property interferes with the safety, comfort, welfare, and/or convenience of property owners or the

WHEREAS, the City, in most cases does not have legal authority to make drainage improvements on private property; and

WHEREAS, the City is willing to award assistance to promote the improvement of drainage facilities on private property and to correct illicit discharges and/or illicit connections on private property in accordance with the City of Shelby Stormwater Infrastructure Assistance Program;

NOW, THEREFORE, in consideration of the promises and mutual covenants herein contained, the parties agree as follows:

- 1. The CITY agrees to share in the cost of upgrades or repairs to the stormwater system on or along the property of the OWNER(S) as set forth in, those project plans identified as 203 Montrose Cir. Stormwater Project ... (This work shall be referred to herein as "the Project"). The CITY agrees to pay a pro-rata share representing 80 percent (residential property) or 50 percent (commercial property) of the actual construction costs of the Project for the most feasible, cost efficient solution determined by the CITY for a project on private property. The CITY agrees to pay 100 percent of design costs for a third-party consulting engineer if deemed necessary by the CITY.
- 2. The OWNER(S) agree to pay their pro-rata share representing \( \) 20 percent (residential property) or \( \) 50 percent (commercial property) of the actual construction cost of the Project. OWNER(S) shall pay their share of the cost by depositing with the CITY a minimum amount equal to 50 percent of the preliminary estimated share of the OWNER(S). The remainder of the OWNER(S) share is due at the time of written notification from the CITY of Project completion and total construction costs of the CITY. The OWNER(S) costs will not exceed their pro-rata share of the actual construction costs, and any payment in excess of actual cost will be refunded to the OWNER(S). Should the OWNER(S) choose not to complete the project following a design by a third-party consulting engineer, the OWNER(S) shall pay 50 percent of the engineering design fee.

OWNER(S) may choose to participate in the special assessment payment option, as evidenced by the attachment to this Agreement of a properly executed Note and Instrument Payment Agreement and Deed of Trust. The Project may proceed upon proper execution and submittal to the CITY of the Agreement, Note and Deed of Trust.

OWNER(S) participating in the special assessment payment option are subject to the following conditions:

- a. Applications for installment payments shall be submitted with a non-refundable \$200 application fee to cover credit checks, appraisals, and other costs associated with a special assessment.
- b. A first or second position lien in an amount no greater than 80% of the unencumbered property value will be considered sufficient security for the assessment.
- c. After determination that income, credit history, security, and other normal requirements for the assessment have been met, the application for installment payments will be approved by the City.
- d. The applicant shall submit a deposit at least equal to 10% of the actual construction cost and an executed agreement to pay the remainder in equal payments over a time period not to exceed 5 years. The first payment will be due one year after notification of Project completion by the City.
- e. The minimum assessment amount will be \$1,000.
  - 3. The total project cost shall not exceed \$50,000.

4. The construction contract for the construction of the improvements to the $\boxtimes$ residential or $\square$
commercial property located at 203 Montrose Cir. and described in Deed
Book 17U Page 667 at the Cleveland County Register of Deeds shall be let for bids and awarded in
accordance with Article 8 of Chapter 143 of the North Carolina General Statutes, and specifically including the
requirement that any contract be awarded to the lowest responsible bidder. All obtained bids shall be provided to
the OWNER(S) for review. The CITY reserves the right to refuse any and/or all bids. The total CITY share of the
Project will be 80 percent (residential property) or 50 percent (commercial property) of the actual
construction cost of the improvements for the most feasible, cost efficient solution determined by the CITY for the
Project on private property. The OWNER(S)' share of cost of the project shall not exceed 20 percent (residential
property) or 50 percent (commercial property) of the actual construction cost of the improvements for the most

feasible, cost efficient solution determined by the CITY for the project. The work will be undertaken only if CITY funds are available.

- 5. The CITY shall obtain all temporary construction easements from neighboring property owners. Costs associated with acquiring easements will be included in the total Project costs shared by the CITY and OWNER(S). OWNER(S) shall grant a temporary construction easement to the CITY at no cost.
- 6. The Stormwater Division reviews and approves the design plans and specifications prior to bid solicitation.
  - 7. The work shall conform to City standards and other applicable local, state, and federal requirements.
- 8. The CITY, or a third party delegated by the CITY, shall provide construction oversight and inspections to ensure that the Project is completed in substantial conformance with the proposal.
- 9. In consideration for the CITY's undertaking stormwater drainage improvement assistance on private property, the OWNER(S) hereby agree to discharge, release, and hold harmless the CITY, its agents, employees, and officers, for liability for personal injury or property damage, or both, arising under this Agreement or the work to be performed hereunder. The OWNER(S) hereby agree to discharge, release, and hold harmless the CITY's contractor or contractors for liability for personal injury or property damage, or both, to the extent such are not covered by the contractor's liability insurance.
- 10. The OWNER(S) acknowledge and agree that no action taken or work performed by the CITY pursuant to this Agreement or the official City of Shelby Stormwater Infrastructure Assistance Program shall constitute a taking or appropriation of the stream, ditch, water course, or drainage way on or along their property as part of the CITY's stormwater drainage system. Further, the OWNER(S) acknowledge and agree that the CITY has assumed no liability over, or responsibility for, their property, the drainage way, or any drainage improvements located on their property. The OWNER(S) agree to be responsible for the future maintenance and repair of all drainage facilities and improvements located on their property.
- 11. The undertaking of the Project by the CITY shall be conditioned upon full participation in this Agreement and undertaking by all property owners abutting the Project. The OWNER(S) understand and acknowledge that, in the event any of the Project participants fail to make full payment for the cost of the work, or fail to execute all required documents and agreements, the final approval of the Project will be withheld by the CITY, and this Agreement shall be void and of no effect.
- 12. The CITY and/or the OWNER(S) may withdraw participation in the Project if the actual construction bids exceed the preliminary cost estimate or available City funding.
- 13. These provisions represent the entire Agreement between the parties and may not be modified by oral representations. As used herein, the plural designation may indicate the singular, where applicable.
- 14. The OWNER(S)' share of the funding as outlined above must be paid to the CITY following the completion of design plans and bidding, but prior to the execution of any construction contracts.
- 15. The Project must be expected to have a life cycle of more than five (5) years, therefore the OWNER(S) shall commit to a higher level of maintenance than may have previously been conducted (i.e. maintaining vegetation and/or removing debris from ditches) for a period of five (5) years. The CITY will complete annual inspections during this five (5) year period and notify the OWNER(S) of maintenance issues that exist if any are present.
- NOW, THEREFORE, in consideration of the City's willingness to enter into the Agreement, the undersigned agrees that the Agreement shall be governed by the laws of the State of North Carolina and venue for any civil action between the parties shall be Cleveland County Civil Superior Court.

This Agreement shall be binding on the heirs, personal representatives, successors and assigns of the parties with reference to the subject matter of this Agreement.

#### City Manager's Recommendation / Comments

As Council knows the City provided an \$80,000 – 10 year forgivable loan (thru a CDBG grant) to the Cleveland County Rescue Mission through a past CDBG Catalyst Grant for improvements to the new men's shelter. One of the conditions of the City "passing through" this grant to CCRM is that a deed of trust is filed/recorded and remains in place until either released by the City with approval of the State or the lien is satisfied. In this situation the lien is put into place to prevent a property from being sold by the receiving agency while retaining the proceeds from the sale. There is not the expectation that the \$80,000 be paid back to the City and State otherwise as long as the building is used for the stated purpose as a men's shelter. This request simply asks that the City agreement to subordinate to other lender (BB&T) which has a much larger lien. This request is the result of additional borrowing by the CCRM for construction of a new phase at its Buffalo Street location. There is no risk to the City and I see no reason for Council not to approve this request and authorize the subordination.

It is recommended that Resolution No. 27-2019 be adopted and approved via the Consent Agenda.

#### Executive Summary of issue - Background

In 2012, the City of Shelby received the North Carolina Department of Commerce Division of Community Investment and Assistance 2011 Community Development Block Grant (CDBG) funding assistance. The City completed several projects with these funds including infrastructure (water and sewer) as well as catalyst projects which included housing, and community facilities which was a loan to the Cleveland County Rescue mission.

#### **Review and Comments**

The loan to the Rescue Mission was a \$90,000 loan which was and is forgivable over a period of ten (10) years. The Cleveland County Rescue Mission is moving forward with another phase of its project on Buffalo Street. This phase includes a loan from BB&T. This makes it necessary to subordinate the City's CDBG Loan to a second position for the Rescue Mission to secure this funding.



#### City Manager's Recommendation / Comments

Resolution No. 28-2019 comes before City Council for consideration as new business. In accordance with adopted City policy an application for facility naming was submitted by a group of citizens asking that the current community center (gymnasium, office and game room) at Holly Oak Park be named for Mr. Clarence M. Palmer. The application was reviewed by staff and presented to the Parks and Recreation Advisory Board. The Advisory Board, as required by policy, held three community input workshops her public comment on the proposal. Tonight Council will hear the results of those workshops and the recommendation of the Advisory Board. Following receipt of the information City Council may act as it deems appropriate. If approved Resolution No. 28-2019 would officially rename this facility as the "Clarence M. Palmer Center". Appropriate signage would then be designed and installed in the coming months.

It is my recommendation that Resolution No. 28-2019 be adopted and approved by City Council at this time.

#### Executive Summary of issue – Background

On November 19, 2018, I received a Facility Naming Application Form requesting the Parks and Recreation Advisory Board consider the "Holly Oak Center" (gymnasium, offices and game room) be renamed "Clarence M. Palmer Center." Per the Facility Naming Policy, the Advisory Board held three consecutive monthly "Community Workshops" to discuss and review the application. During these meetings on December 12, January 16 and February 20, approximately 67 citizens attended with 15 speaking to endorse the naming recommendation to the Board. In addition, several dozen emails and letters were received supporting the Application. At the third and final Workshop on February 20, the Advisory Board took action and voted unanimously to recommend to City Council that the request be approved. As indicated on the application, among many other things, Mr. Palmer was employed by the City of Shelby from 1954 until 1977 as Holly Oak Park Superintendent, and was instrumental in the building of the Holly Oak Center in 1959. He was a Trustee, Church Treasurer, and Sunday School Superintendent at Wardell AME Church. Mr. Palmer was the first African-American ever elected to public office as a City School Board Member in 1970. He was a member of the American Legion, served on the Cleveland County United Fund Project, Mental Health Association, March of Dimes and Red Cross.

Mr. Palmer was a Veteran and recipient of the Purple Heart and Bronze Star Medal for Valor.

Mr. Palmer was described in the application as "an absolute pillar of strength and respect within the community. A man of integrity dedicated to building community excellence."

#### Recommendation

Having adhered to policy, the Shelby Parks and Recreation Advisory Board wholeheartedly endorsed this naming application on February 20, 2019.

Therefore, it is my recommendation and request to you that consideration be given to the approval of the recommendation to rename the "Holly Oak Center" to "Clarence M. Palmer Center". Should this request be approved, staff will obtain and install the appropriate signage and ensure that a dedication ceremony take place at the appropriate time.

Modestenia Bush - A book was published entitled "The Day They Marched." It documents a movement spearheaded by various leaders for better jobs and freedom. It documents leaders who were called and how the people answered. In that same sense of leadership dedication, Mr. Clarence M. Palmer was called to spearhead a place of peace, fun and tranquility. Mr. Palmer answered the call to be the Director at Holly Oak Park. His dedication was evident because he accepted the position in a much smaller town than his own native town of Durham, NC.

Our history included days of segregation. During the times when black people were not permitted to frequent certain places, the Holly Oak Park, under the direction of Mr. Palmer, provided recreation that is so necessary and vital to our lives. The days of segregation cannot be erased. Our lives were segregated but under his direction, we experienced good times. Mr. Palmer was able to instill in the minds of the young and older people that recreation was important and necessary. His name resonates high along with the great notable names in our history. He went to great lengths to help all people, especially the youth of Cleveland County. Some of the people who experienced the love and caring from Mr. Palmer went on to become lawyers, doctors, nurses, teachers, entrepreneurs, contract specialist, consultants, professional sportsmen, military veterans, welders, fire fighters, preachers and much more. One of his protégés became the park director himself, Mr. Wayne Merritt. His love and carrying was not only for the young and old; his love was exhibited in his dog Sunny, a beautiful black Newfoundland. He also loved his Labrador named Linda.

Mr. Palmer, along with his wife, Patricia, orchestrated many often times with out-of-pocket expenses. He instilled into the minds of everyone who visited the park the rules about respect for the facilities and property. He did not allow any destruction of the facilities nor horseplay in the pool nor on the playground. He did not permit any foul language. He had a watchful eye for the upkeep of the property because he lived on the premises. His rules applied to all visitors, as well as those from miles around who came to enjoy the park which was and, to this day, is well known. They came by cars and buses from Charlotte, NC, Georgia, Tennessee, South Carolina and other places. They were met with a welcome and park rules from the Director. His knowledge for food handling enabled him to manage a food service where you could buy tasty hot dogs and hamburgers, a drink and chips while at the park. He brought entertainment to the park; celebrities such as Floyd Patterson, singers like Joe Tex and other groups. He trained lifeguards and orchestrated synchronized swimming shows, baseball and softball activities. He collaborated with others to sponsor an annual Fourth of July celebration event which included kiddy rides and special events throughout the day. –

Rufus D. Parker - I would like to recommend Holy Oak Park Center to be named in honor of Mr. Clarence Palmer. Mr. Palmer reached out to Cleveland County Community encouraging black youth and adults to participate in the programs that were offered at Holy Oak Park. Holy Oak Park offered swimming classes to youth, as well as adults during the summer along with youth and adult baseball and softball leagues. There was free transportation during the summer months for many families that didn't have transportation. During the segregation era of the 1940's, 1950's and early 1960's, this park offered a safe haven for the black community in which during the time black people were not welcome at other city parks. Mr. Palmer made everybody feel welcome regardless of race or color. His spirit will always arouse the membrane of the generation living today who experienced his leadership. He possessed a personality that expressed deep love for the community. His legacy should live on as long as Holy Oak Park exists. I believe the entire Cleveland County would agree in renaming the present Center after Mr. Clarence M. Palmer. - Mr. and Mrs. Rufus D. Parker, Entrepreneur, Shelby, NC

William (Butch) Mitchell - Mr. Clarence Palmer was Holly Oak Park. He instilled into us character and strength and helped to develop our natural abilities.

I will never forget the time Mr. Palmer was teaching us how to dive into the ten feet deep end of the pool. I thought he told us to jump in; but when I dove into the pool, I sank to the bottom and panicked. Mr. Palmer and some of his trained lifeguards rescued me. He was a gentle giant. All he could say was "little pudding,

why did you do that?" Later in life, he would tease me often about that time. He was caring and wanted all in the swimming class to do well. We looked forward to coming to his class to learn more diving and floating. The best part about learning to swim was the water shows. We performed before our parents and the public. Mr. Palmer made Holly Oak Park a special place. I recommend renaming the Center at Holly Oak Park to the Clarence M. Palmer Community Center. - Bonita Wesson, Homemaker, Shelby, NC

William B. Oglesby (Willie B) - I remember when I was young visiting the park sometimes; early before the pool was opened for operation. I remember watching Mr. Palmer float in the middle of the pool. It was so fascinating, because he appeared to be asleep. I was not a swimmer at the time, and I wondered how he could do this because he was big in stature. I also remember another time when Mr. Palmer and Melvin, his trained lifeguard, were on the lake. Melvin was water skiing and Mr. Palmer was steering the boat. I think these were truly fun times for all of us, and Mr. Palmer was a humanitarian and just such a wonderfully nice person. I carried many Mr. Palmer's disciplinary teachings into adulthood, even as an enlisted serviceman in the U.S. Marine Corp. I recommend renaming the Center at Holly Oak Park to the Clarence M. Palmer Community Center. – William B. Oglesby – Retired Army Substance Abuse Program Manager, Winston Salem, NC – (Veteran, U.S. Marine Corp)

Bishop Michael Moore –Mr. Clarence Palmer was Mr. Holly Oak Park. He instilled character and discipline. His teachings prepared us for life and he trained a lot of lifeguards. Billy C. Sanders – The Holly Oak Park facility should, and it is my desire, be named in honor of Mr. Clarence Palmer. Mr. Clarence Palmer was a leader who instilled direction and discipline in the lives of black youth in Cleveland County. He should be recognized for the contributions he made during his tenure. Every family who utilized the Holly Oak Park facilities was exposed to well-organized yearly social activities. Mr. Palmer's leadership of the summer swimming program was one of the best in the state. All lifeguards met strict state training guidelines and developed into excellent collegiate swim team members. He organized a summer league softball program that had huge crowds in attendance each night of competition. Some of our most outstanding female and male athletes played in these leagues. The programs also assured that African American youth had activities to be involved in that were well planned and organized. Mr. Palmer envisioned and implemented concepts of team play, discipline and support for fellow teammates that were adhered to at all times. As a young boy growing up in Shelby, Mr. Palmer's creation of a youth age group football program was paramount in my life. I credit that program with establishing the ground work for my advancement into a college level football achiever. Without that beginning and opportunities in the youth age group program, I could have easily moved in other directions that may not have been with positive benefits. I was honored to have been given a job responsibility by Mr. Palmer to clean the park areas. My family needed that monetary support. There are many other attributes about Mr. Palmer that I could write about that

impacted the lives of Shelby youth and community supporters. He was a man of integrity dedicated to building a community of excellence. I thank God for a man of his statue in my life. I sincerely endorse and gladly support having the name of Mr. Clarence Palmer affixed to the recreation center for youth and community of Shelby, North Carolina. -Dennis G. J. Grace McDougall Chavious – As a resident on Holly Oak Drive, I think of fun times while living and growing up inside the Holly Oak Park. Many times, it seemed that people thought those of us who lived in the small neighborhood in the Park were a park fixture. I think of a natural setting that was just beautiful and that we as Afro Americans in Shelby, NC, were blessed to have as a recreational area. It had a competitive-sized swimming pool, huge playgrounds, two lovely lakes for boating, along with fishing, tennis courts; two recreation centers that were built as a result of progressive action by Mr. Palmer working with an active Black community, a large ball field for playing popular active sports. These recreational opportunities were all there at an unbelievable time, years and years ago, when this environment enabled us as young people to compete; to have fun, and to evolve competitively, morally and successfully into strong adults. Along this path, Mr. Palmer, the Director of Holly Oak Park, worked with the community to create a positive environment for that growth. He came from that same generation that included our parents and, as a result, many wonderful things happened in the Park. One of the stereotypes that I remember was that Black kids did not usually swim. Mr. Palmer instituted structured classes where any child or adult in Shelby or Cleveland County could take swim classes at beginner's, intermediate and advanced levels. Just about everyone in our area learned to swim competitively with grace and style. He initiated water-safety classes where many of us became junior/senior life guards and, through his direction, went onto receive our water-safety instructor's certificates. He designed water shows where we displayed our swim styles and learned to swim in unison in a beautiful scenic atmosphere. As a result, we were proud of our many accomplished swim shows which helped to create confidence, grace, integrity and pride in our skills. In conjunction with that, he established ball teams where kids could display their baseball, softball and football skills by working with athletes in the community to sponsor leagues that encouraged competition and recreation. There were scheduled ball games that allowed families to attend and cheer for

their children who were members of various teams that Mr. Palmer helped create through his work with the town and its respective members. The games were enjoyed by many and established an arena for some of its players to go on to compete as successful professional athletes. Tennis was another popular sport that was encouraged by Mr. Palmer through his participation in the community. I remember watching my parents play this wonderful sport during their time off; playing tennis with each other and with friends. It was amazing what our town was exposed to at a time when recreational opportunities for Afro Americans in small Southern towns were unheard of, yet we were exposed to it. Mr. Palmer seemed to enjoy and operate in this environment as if he had created it. His directing Holly Oak Park did not seem like a job to him. There were scheduled activities at the center which encouraged competitive basketball games, ping pong competitions and even weekend shows where performers came to entertain the community. All these scheduled events were orchestrated by Mr. Palmer. People came by bus loads from all over North Carolina from one end of the state to another. They came from other states such as South Carolina, Virginia, Tennessee, etc. Sometimes, there were as many as 100+ buses from all over on holidays like Independence Day, Labor Day and others. I think that Mr. Palmer's contributions to Holly Oak Park should not be forgotten and that many of us who grew up in Shelby will never forget them, as well. Hopefully, the creation of a memorial in his name will not only honor him but will also serve as a happy reminder to all of us of the many good times we shared in our evolution to becoming good adults. - Grace McDougall Chavious, Winston Salem, NC

Richard A. Bradley – It is so deserving that a man who's humble beginnings started with an old horse barn that was donated and turned into a recreation center for which Mr. Clarence M. Palmer was named the Director. During his tenure of 23-years, he brought many programs to the park, and was instrumental in the building of the existing community center in 1959. He taught lifesaving classes and I was trained as a lifeguard. He helped to build self-confidence with his style of teaching. Walking to the park did not seem, at the time, to be such a long distance to walk since I lived on the far side of town. Clarence M. Palmer, the irst black to hold an elected ffice in Shelby, died this norning apparently of a heart attack.

Today was to have been his last day as director of folly Oak Park, a position rom which he was retiring after 23 years.

"I really thought a lot of nim," commented Parks Superintendent Fain Hamrick this morning.

"Clarence was a good citizen," \added a local ewspaperman.

A former member of the first black to be elected to public office in Shelby. He was first appointed to the board in 1970 to fill the unexpired term of Harry Matthews and was elected in 1971 to his first full, four-

year term.
"The children of Shelby," he once said, "must have the best educational op-portunities we can provide for them."

A native of Baltimore, Palmer came to Shelby in 1954 after being a physical education and recreation instructor at N.C. Central University, where he had been an undergraduate and

graduate student. He had held jobs with the recreation departments in Durham and Greensboro and for a while was a teacher and principal with the Granville County School

He provided for the kids who couldn't. everyone was at Holly Oak Park. We worked 8am-10pm. Mr. Palmer instilled respect in me. I grew up to be a fireman and retired from the city."

#### James Martin-

"Mr. Palmer was a great man. He loved us and we loved him. I served on the trustee board with him. Mr. Palmer called me one day and asked for my help. There were some fellas that wanted to take away the playground. They decided to move it to Hunter's school. One young student didn't graduate because of English. We decided to have a tutoring program 2-3 nights a week. We decided to extend the program, and it was a success thanks to Mr. Palmer. He wasn't only a director but a great father figure. I never saw him get angry, he was a big guy. He didn't have to get angry. Just his presence got things done. He gave as many of us as he could an opportunity. He was an outstanding man. We would sit and talk and watch the animal eat. 'No Matter how dark the night there will always be the coming of dawn'".

#### Charles Degree -

"I was raised with My. Palmer. He gave me my first job. Then again at the pool. He taught me how to balance a check book. He had a very strong influence on us. He started the Cleveland county boys club. He lead my sports teams. He knew everyone by name. He told me never to be late. He went out of his way to help others. He was a strong influence on others. I would strongly recommend naming the center "Clarence M. Palmer Community Center" July 4<sup>th</sup>, we would ask the regulars not to come so we could welcome guest. I would love to tell our young people about Mr. Palmer. He was the most important man in my life.

#### Joyce Coleman-

"I want to share on a parent's point of view. We looked forward to going got Holly Oak Park. Even though we were at the lower end of the county. We would gather together to walk to Holly Oak Park. I raised my children at Holly Oak Park. We started Girl Scouts and brought them to Holly Oak. We all learned to swim at Holly Oak. Mr. Palmer has done so much for so many in the county. We want it to be renamed in his honor so we can carry out his memory.

Allen thanked the group. Charlie shared the naming book with the group and thanked them.

Dorothy Crawford -

Shared pictures with the Board. "I worked here for 3 years in the gym. I stayed closed to the park. I would go every day after school. There were a lot of back to school activities and family reunions held at Holly Oak Park."

The Board moved back to the conference room to discuss at 1:07pm.

Allen Langley opened the floor for discussion.

Bill Young felt confident that the vote would be unanimous in favor of the renaming. Marie Hendrick stated that she was overwhelmed by the amount of support the community has shown towards the renaming process. Shanda Hoskins shared that she was taken back but the impact Mr. Palmer made on the kids in the community and how it has effected generation after generation.

Allen opened the floor for a motion to vote, David Lynn made a motion to approve the Clarence M. Palmer facility naming request, seconded by Shanda Hoskins. Members unanimously voted in favor to make a recommendation to City Council supporting the naming of Holly Oak Center to Clarence M. Palmer Center.

Allen shared with the guests the vote was unanimous in favor of the request. Charlie shared that the recommendation and renaming application will be sent to City Council.
