Mayor Anthony called the meeting to order at 6:00 p.m. and delivered the invocation.

Mr. Causby led the Pledge of Allegiance.

A. Approval of agenda:

ACTION TAKEN: Upon a motion made by Mr. White, City Council voted unanimously to approve the agenda as presented.

B. Special Presentations:

1) Recognition of Fire Chief William Hunt as 2021 Career Fire Chief of the Year by the North Carolina Association of Fire Chiefs (NCAFC)

Mayor Anthony called upon Fire Chief William Hunt and formally presented the plaque designating him as the 2021 Career Fire Chief of the Year by the North Carolina Association of Fire Chiefs (NCAFC). As background, the selection criteria emphasize leadership, innovation, professional development, integrity, service to the public, and contributions to fire service. A nominee's entire fire service activities and accomplishments are considered by the NCAFC Fire Chief of the Year Committee.

Chief Hunt recognized the Shelby Fire and Rescue team as well as those in attendance: Division Chief David Vanhoy, Battalion Chief Clint Beam, and Fire Marshal Phillip Lane.

2) Recognition of Director of Finance, Beth B. Beam, and the City of Shelby's Finance Department as recipients of the Certificate of Achievement for Excellence in Financial Reporting awarded by the Government Finance Officers Association for Fiscal Year ended June 30, 2020

Acknowledging a long legacy, Mayor Anthony was pleased to announce that the Government Finance Officers Association awarded the Certificate of Achievement for Excellence in Financial Reporting to the City of Shelby for its Comprehensive Annual Financial Report (CAFR) yet again. When a Certificate of Achievement is awarded to a government, an Award of Financial Reporting Achievement (AFRA) is also presented to the department designated by the government as primarily responsible for its having earned the Certificate. The Mayor noted it is a testament to the commitment of past and present management and finance directors, whose work is often taken for granted, as to full public disclosure and communication of the financial condition of the City of Shelby.

Noting this is the 24th year the award has been received by the City of Shelby, Mayor Anthony recognized and congratulated Finance Director Beth Beam as she accepted the Certificate of Achievement on behalf of the City of Shelby and the Award of Financial Reporting Achievement on behalf of the Finance Department.

- D. Public Hearings:
 - 1) Consideration of a proposed ordinance amending the zoning map of the City of Shelby, North Carolina (1855 East Dixon Boulevard): Ordinance No. 21-2021

Mr. Scharer introduced a zoning map amendment for property located at 1855 East Dixon Boulevard and west of Cleveland Mall, from Residential 10 (R10) zoning district to General Business (GB) zoning district. He stated the site is currently vacant and undeveloped. The property is currently split zoned R10 and GB. The applicant, Jolu, Inc., is seeking to eliminate the split zoning on this property and requesting the entire property be zoned GB.

Mr. Scharer concluded by stating staff recommended approval of this proposed zoning map amendment, which is reasonable and consistent with the Shelby Comprehensive Land Use Plan. The Planning and Zoning Board also recommended approval of the proposed zoning map amendment.

Mayor Anthony opened the public hearing at 6:08 p.m. and invited comments from the public.

The public offered no comments.

Mayor Anthony closed the public hearing at 6:09 p.m.

ACTION TAKEN: Upon a motion made by Mr. Causby, City Council voted unanimously to approve and adopt Ordinance No. 21-2021 entitled, "A PROPOSED ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF SHELBY, NORTH CAROLINA".

2) Consideration of a proposed ordinance amending the zoning map of the City of Shelby, North Carolina (1100 Buffalo Street and 706 Julius Street): Ordinance No. 22-2021

Mr. Scharer introduced the proposed conditional zoning map amendment from Residential Office (RO), Residential 6 (R6), and Neighborhood Business (NB) zoning districts to Residential Office-Conditional Zoning at 1100 Buffalo Street and 706 Julius Street. The applicant, Western Carolina Rescue Ministries, Inc., is proposing a zoning change to these properties in order for the men's shelter and women's shelter to be in close proximity of each other.

Mr. Scharer stated the former men's shelter is now the women's and children's shelter at 1100 Buffalo Street. The new men's shelter, a former warehouse, will be located at 706 Julius Street. The amendment would allow these two shelters to be within 300 feet of each other. Both are operated by the Cleveland County Rescue Mission.

Mr. Scharer explained the conditional zoning districts are established to allow the City Council to consider proposed uses and tailor the zoning to accommodate those uses and promote innovative design while addressing anticipated problems that may arise from the establishment of the proposed uses. The conditional zoning district approval process allows the City Council to approve a proposal for a specific use with reasonable conditions to assure the compatibility of the use with surrounding properties. This is a voluntary procedure intended for firm development proposals. Uses that may be proposed and considered for a conditional zoning district shall be restricted to those uses permitted in the underlying general zoning district.

Mr. Scharer added this proposed conditional zoning map amendment proposes all the same development standards for homeless shelters in Article 11 aside from the use separation requirements. This proposal does not remove the use separation requirement for all homeless shelters; however, this proposal does allow the properties at 706 Julius Street and 1100 Buffalo Street to operate within the previously required use separation.

The applicant is proposing and consents to the following conditions:

- 1. The use must be operated by a resident owner or manager.
- 2. The use shall be owned and managed by a charitable or benevolent operation qualifying for tax exemption under Section 501 of the Internal Revenue Code as amended.
- 3. There shall be no compensation required for occupancy in the shelter.
- 4. There shall be a minimum of fifty square feet of sleeping space per person.
- 5. The special use permit authorizing such use shall be renewed annually (every 12 months) by the Board of Adjustment. Failure to apply for renewal within the specified time period shall render the special use permit null and void. The special use permit may be revoked by Board of Adjustment at any time upon a finding that the use has caused a habitual nuisance to adjacent properties.
- 6. There may be one unlighted sign erected, not to exceed three feet in height and three feet in sign area.

Mayor Anthony opened the public hearing at 6:13 p.m. and invited comments from the public.

The public offered no comments.

Mayor Anthony closed the public hearing at 6:14 p.m.

3) Proposed Fiscal Year (FY) 2021-2022 Annual Operating Budget for the City of Shelby

As a reminder, Mayor Anthony stated Mr. Howell had previously presented the proposed Fiscal Year (FY) 2021-2022 Annual Operating Budget for the City of Shelby to Council at their regularly scheduled meetings of May 17, 2021 and June 7, 2021. The Mayor added the City of Shelby General Fund Budget Presentation, Fiscal Year (FY) 2021-2022; the City of Shelby Utility (Enterprise) Funds Budget Presentation, Fiscal Year (FY) 2021-2022; Mr. Howell's Budget Message; the Proposed Budget Ordinance; and the Proposed Supplemental Budget Ordinance, were posted to the City's website for public access and review as well as made available for public inspection at City Hall. Lastly, the public hearing notice has been advertised as required.

Mayor Anthony opened the public hearing at 6:15 p.m. and invited comments from the public.

The public offered no comments.

Mayor Anthony closed the public hearing at 6:16 p.m.

G. New Business:

1) Consideration of a resolution authorizing selection of Kimley-Horn based on qualifications for the 24-inch water transmission line to the South tank and Forest Hill Drive: Resolution No. 42-2021

Mr. Howell introduced Resolution No. 42-2021 for Council's consideration. As background information and as an overview of the project, he stated since 2009, the City of Shelby identified low water pressure and low flow issues in the eastern portions of the City's water distribution system. The system was able to meet normal consumption needs and fire protection; however, the system struggled with increased demand times associated with commercial and institutional demand, fire hydrant flushing and fire suppression. Most of these pressure and flow issues stem from lack of an adequately sized distribution lines from the Water Treatment Plant (WTP) to the eastern portions of the system and the lack of water storage around the Cleveland Community College area. Engineering reviews recommended a phased approach including the construction of an elevated storage tank in the East and installation of a major distribution waterline from the City's WTP to the elevated storage tanks in the North and South and eventually a new East tank.

Mr. Howell further stated the City began planning and construction of several large projects to help alleviate the issues in the eastern sections of the City. Some additional key steps of improvements along the way have included:

- 2015-2017 Design and construction of the East tank at Kemper Road and Marion Street
- 2015-2018 Design and construction of Grover-Morgan 24-inch waterline from WTP to Marion Street and Morgan Street intersection
- 2016 Water Model Evaluation of the City's Water System Included proposed system improvement projects and waterline sizing verification

 2016 Waterline Planning Document providing routes and estimates for construction of 24-inch waterline to South and East tanks. This document included the phasing of these projects.

Mr. Howell added the completion of the East tank and main distribution waterline to the Uptown area have helped to improve the water situation in the East; however, the City must continue to construct a 24-inch waterline across Shelby to help provide adequate water for future economic development and fire protection. Since the problem was identified, the City has seen increased development in the East with Cleveland Community College, residential, and commercial growth. With this growth, the additional capacities in the east are further reduced because of the hydraulic limitations of smaller distribution lines.

Mr. Howell stated with these activities/projects completed, the next phase is the design and construction a 24-inch water line extending service from the Marion Street and Morgan Street intersection to the South tank. This new line would be installed along Market and Morgan Streets paralleling the old Norfolk Southern Railroad (Rail Trail Corridor), turning east on McDowell Street and then onto South Lafayette Street to the South Tank. There will be several interconnections to the existing distribution system along the route. From the intersection of Graham Street and Morgan Street, a 24-inch line would extend east to Beaumonde Avenue and then to Forest Hill Drive. There will be several interconnections to the existing system along the route. A major connection would be made at the intersection of Dekalb and Graham Streets to the 12-inch line that feeds the City's North tank.

As part of the project, altitude valves will be installed at the North and South tanks. These altitude valves will allow the City to force additional water flow to the eastern portion of the system towards the East tank. This will help to continue to enhance water distribution to the East tank area until the City can complete the additional phases needed to extend the main 24-inch distribution line to the East tank.

Mr. Howell concluded by stating the City follows a request for qualifications (RFQ) process. After scoring the RFQs, staff recommended the approval of the resolution selecting Kimley-Horn and Associates, Inc. of Charlotte, North Carolina to perform the engineering services for the 24-inch Water Transmission Line Extension to the South Tank and Forest Hill Drive Project. The resolution also authorizes the City Manager to then negotiate and execute an agreement establishing the scope of work and fees associated with the required engineering services. It was noted the City has contracted with Kimley-Horn in the past for the design of the 24-inch water transmission loop line from the Water Treatment Plant on Grover Street to Washburn Switch Road as part of the Clearwater Paper Corporation expansion.

ACTION TAKEN: Upon a motion made by Mr. Hopper, City Council voted unanimously to approve and adopt Resolution No. 42-2021 entitled, "A RESOLUTION AUTHORIZING SELECTION OF KIMLEY-HORN BASED ON QUALIFICATIONS FOR THE 24-INCH WATER TRANSMISSION LINE TO THE SOUTH TANK AND FOREST HILL DRIVE".

2) Consideration of a resolution authorizing selection of WithersRavenel based on qualifications for the Hickory Creek Sewer Outfall Replacement: Resolution No. 43-2021

Mr. Howell introduced Resolution No. 43-2021 for Council's consideration. As background information and as an overview of the project, he stated the gravity sections of Hickory Creek Outfall from south of Highway 74 to Windsor Drive was initially installed in the 1950s and were constructed utilizing vitrified clay pipe (VCP). Some of these sections were relocated during the late 1990s and constructed with ductile iron pipe (DIP). Staff identified this area as a high priority area of the sanitary sewer system because of the number of sanitary sewer overflows over the past 10 plus years. In 2015, the City contracted an engineering firm to complete an evaluation of the Hickory Creek Sewer Outfall utilizing flow monitoring and surveying of the outfall. The engineering evaluation determined that the outfall had several sections that are laid at either reverse or flat grade, thereby reducing the system flow capacity during dry weather flows and wet weather events. The reduction of the system flows during rain events created hydraulic problems resulting in large sanitary sewer overflows.

Mr. Howell further stated system improvements would include the re-laying of sewer line from Highway 74 to Windsor Drive to provide adequate hydraulic capacity by installing the sewer line at proper grades, thus reducing the number of sanitary sewer overflows in the Windsor Drive and Kings Road area.

Mr. Howell concluded by stating the City follows a request for qualifications (RFQ) process. After scoring the RFQs, staff recommended the approval of the resolution selecting WithersRavenel of Asheville, North Carolina to perform the engineering services for the Hickory Creek Sewer Outfall Replacement Project. The resolution also authorizes the City Manager to then negotiate and execute an agreement establishing the scope of work and fees associated with the required engineering services. It was noted the City has contracted with WithersRavenel in the past for the completion of a water and sewer rate study and the update of the Transportation Asset Management Plan.

ACTION TAKEN: Upon a motion made by Mr. Webber, City Council voted unanimously to approve and adopt Resolution No. 43-2021 entitled, "A RESOLUTION AUTHORIZING SELECTION OF WITHERSRAVENEL BASED ON

QUALIFICATIONS FOR THE HICKORY CREEK SEWER OUTFALL REPLACEMENT".

H. City Manager's Report:

- 1) 2009 City of Shelby Comprehensive Land Use Plan Mr. Howell said staff will be sharing recommendations regarding the process involved for the update of this plan.
- 2) Shelby Rail Trail Project Mr. Howell recalled Council's previous approval for the design and engineering services related to Phase I of this project which should be ready to bid in December 2021. He also stated the US Department of Transportation (DOT) is accepting applications for \$1 billion in Fiscal Year (FY) 2021 discretionary grant funding through the Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grants, formerly known as BUILD and TIGER. The City of Shelby is submitting its second application in the hopes of receiving a \$25 million grant which would allow the City to build not only the City portion but the entire proposed Rail Trail, including improvements to crossing roads and access sidewalks along the trail. He mentioned the City has garnered the support of US Representative Virginia Foxx, US Senator Richard Burr, and US Senator Thom Tillis for its pending grant application.
- 3) Depot Park Mr. Howell acknowledged the private donation and pledge agreement for \$1 million gifted to the City of Shelby for the Shelby Rail Trail Depot Park. A public announcement may be made if and when appropriate.
- 4) 1641 Farmville Road Mr. Howell reminded Council the City in partnership with the Cleveland County Economic Development Partnership (CCEDP) and Cleveland County have worked toward completing due diligence to prepare City/County jointly owned sites for consideration by economic development clients. The civil engineering services related to the site development of 1641 Farmville Road are almost complete and a presentation of the project to City Council and the County Commissioners will be scheduled. He mentioned the fees associated with the professional services were paid by grant funding provided by Duke Energy and secured by CCEDP.

- 9) First Broad River Trail Mr. Howell reported a significant portion of the trail has been rebuilt and is partially opened south of the suspension bridge towards the Ingles' parking lot. Repairs to the suspension bridge are ongoing while the bridge and the trail north remain closed.
- 10) Mr. Merritt provided an update regarding the Community Development Block Grant (CDBG) funds for the NC CDBG Coronavirus (CDBG-CV) Program released to the City in the amount of \$900,000. Initially, he stated the City based its award on public service subsistence payments to prevent utility disconnections. Additionally, the City was exploring ways to assist those who have no or limited access to broadband. The priority in this category is broadband services and enhancing internet access that supports increased connectivity to schools, jobs, and healthcare. The City is working with its team partners, United Way of Cleveland County and Cleveland County Development Corporation, to administer the funds under the correct conditions to be clarified and confirmed by the Grant Program Manager. Once written confirmation, which is preferred, is received, a public notice soliciting applications will be published and the funds can be administered into the community.

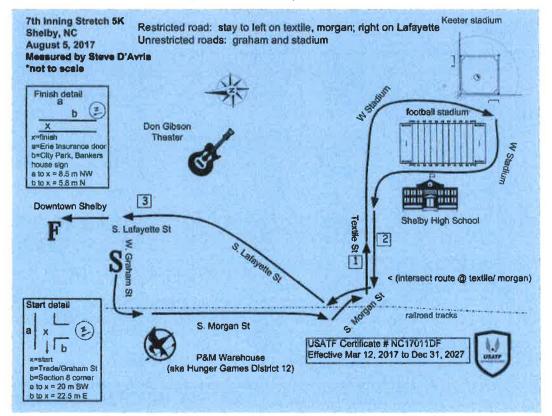

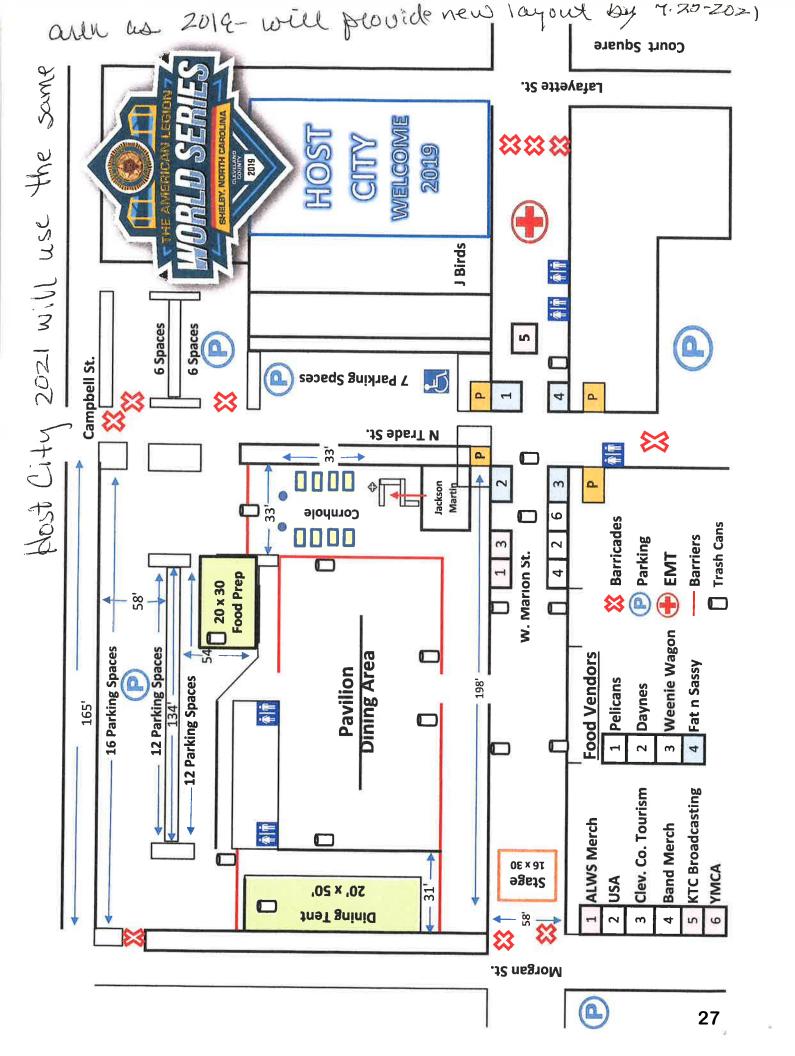

If approved this ordinance would authorize a budgetary adjustment due to natural gas purchase for resale increasing as a result of increased sales of natural gas. You will recall that the commodity price of gas is passed through directly to customers based upon a weighted average cost of gas or WACOG. This amendment truly reflects an increase in natural gas purchases necessary to meet customer demand over what was initially budgeted. This amendment is necessary to comply with the NC Local Government Budget and Fiscal Control Act (NCGS 159-8) requiring that the budget be balanced throughout the fiscal year.

It is recommended that Ordinance No. 27-2021 be adopted and approved via the Consent Agenda.

Subject: FY22 Fee Schedule revision for one water service rate

Background:

Recently, WithersRavenel completed a Water and Sewer Rate Study for the City of Shelby which resulted in recommendations for the water and sewer rates for the next few years. Council has previously adopted the Fee Schedule in the Supplemental Budget Ordinance on June 21st, 2021 which included the recommendations for the water and sewer rates for year one as provided by WithersRavenel.

Review:

Upon entry of the new rates into the billing software, it was determined that one of the rates, specifically the rate for the Customer Charge per consumption unit for residential water service inside the City, was incorrectly listed in the Fee Schedule as \$13.25 per consumption unit instead of the recommended \$14.25 rate per consumption unit.

Recommendation:

Background:

The City intends to apply for a USDOT Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant to provide finding for a multi-use rail trail on the previously purchased Norfolk Southern rail corridor.

The Shelby Regional Access Improvement Line (Shelby R.A.I.L.) project envisions a safe off-street 9.95 mile bicycle and pedestrian corridor and 3.9 miles of connecting spurs for cyclists and pedestrians of all socio-economic backgrounds to utilize for equitable alternative rural transportation from Shelby to the North Carolina-South Carolina state line and return. The R.A.I.L. will complement ongoing and future community and economic development efforts throughout Cleveland County, and will create much needed physical and economic connections between Shelby (regional central business district and county seat), Patterson Springs, and Earl (both bedroom communities with limited commerce), for low-and-moderate income (LMI) neighborhoods whose residents may not own vehicles. The R.A.I.L. facilitates safe non-vehicular access to employment opportunities, parks, commercial and retail centers, cultural and educational resources, medical facilities, and residential districts near the corridor. The City is seeking funding in whole for all three sections, or in part for the Shelby Section with independent utility.

The attached resolution will authorize the City Manager and Assistant City Manager to execute all documents needed to apply for the grant and receive the grant funds, should an award be made.

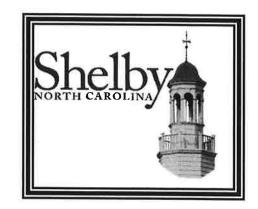

- I, Beth Beam, Finance Director of the City of Shelby, North Carolina (the "City"), having been designated by the City Council of the City (the "City Council") to make and file with the City Clerk a statement of total estimated interest pursuant to The Local Government Bond Act, as amended, DO HEREBY CERTIFY as follows:
- 1. On July 19, 2021, the City Council introduced a bond order authorizing the issuance by the City of \$10,000,000 Street and Sidewalk Improvement Bonds (the "Bonds").
- 2. If the Bonds are duly authorized and issued, I have estimated that the total amount of interest to be paid by the City over the expected term of the Bonds to be \$4,200,000. Such estimate is based on the following assumptions:
- (a) The Bonds will be issued in the aggregate principal amount of \$10,000,000 in three separate series of \$5,000,000, \$3,000,000 and \$2,000,000 each.
- (b) The first series of Bonds will mature or be payable in twenty (20) annual principal installments of \$250,000 per year, the first principal payment which will come due on the first anniversary date of issuance of such series of Bonds. The second series of Bonds will mature or be payable in twenty (20) annual principal installments of \$150,000 per year, the first principal payment which will come due on the first anniversary date of issuance of such series of Bonds. The third series of Bonds will mature or be payable in twenty (20) annual principal installments of \$100,000 per year, the first principal payment which will come due on the first anniversary date of issuance of such series of Bonds.
- (c) The Bonds will bear interest payable semiannually at an average interest rate of 4.00% per annum. Such interest rate is a conservative rate as compared to current market rates and is being used by the City for planning purposes.

The total estimated amount of interest on the Bonds over the expected terms of the Bonds is preliminary and for general purposes only. The City makes no assurances that the assumptions upon which such estimate is based will occur, and the occurrence of certain of such assumption is beyond the control of the City. Differences between the actual circumstances at the time the Bonds are issued and the assumptions set forth above could result in significant differences between the total amount of estimated interest and the total amount of actual interest to be paid on the Bonds if and when issued. The validity of the Bonds is not subject to challenge on the grounds that the actual interest to be paid on the Bonds when issued is different than the total amount of estimated interest on the Bonds set forth above.

- 2. That taxes shall be levied in an amount sufficient to pay the principal of and the interest on said bonds.
- 3. That a sworn statement of the debt of said City has been filed with the City Clerk and is open to public inspection.
- 4. That this order shall take effect when approved by the voters of said City at a referendum as provided in said Act.

The foregoing order has been introduced and a sworn statement of debt has been filed under the Local Government Bond Act showing the appraised value of the City of Shelby, North Carolina to be \$2,584,164,424 and the net debt thereof, including the proposed bonds, to be \$10,000,000. The Finance Director of said City has filed a statement estimating that the total amount of interest that will be paid on the proposed bonds over the expected term of the bonds, if issued, is \$4,200,000. The estimate is preliminary, is for general informational purposes only, and may differ from the actual interest paid on such bonds. Such statement of estimated interest includes certain assumptions upon which such estimate is based, and there is no assurance that the circumstances included in such assumptions will occur. The validity of the proposed bonds is not subject to challenge on the grounds that the actual interest cost on the bonds when issued is different than the estimated interest amount set forth above.

A tax will be levied to pay the principal of and interest on the bonds if they are issued. APPLICATION DUE DATE

The Local Government Commission (the "LGC") meets the first Tuesday of each month, unless otherwise announced, to conduct its business, including the approval of applications of units of government to incur debt. Generally, to allow adequate review of applications, the staff of the LGC (the "staff") requires that applications be received no later than twenty-five days prior to the date of the LGC meeting at which the unit wants its application to be considered. However, in more complex transactions the staff may require earlier submission.

Although this application form is available to interested parties by internet access; the project and the related proposed financing should be discussed with the staff prior to submission of an application. Before the application is accepted for submission to the LGC a preliminary conference may be required (G.S. 159-149).

State law G.S. 120 - 157.1 – 157.4 adopted and effective on June 24, 2011 (Session Law 2011-291), requires that certain capital projects to be financed with debt in an amount exceeding \$1,000,000 be reported to the Joint Legislative Committee on Local Government and to the Fiscal Research Division of the North Carolina General Assembly at least 45 days before the application for debt is to be considered for approval by the Local Government Commission. The law applies to all capital projects to be financed by issuing debt over \$1,000,000 with the exception of schools, jails, courthouses and administrative buildings. Copies of the reporting should also be sent to our office at the time of the filing.

This reporting duty is the responsibility of each local government unit. Each unit should consult its attorney or bond counsel for legal advice on complying with the reporting requirements of this statute.

STATEMENT OF ESTIMATED INTEREST ON THE BONDS

State law G.S. 159-55 rewritten, adopted and effective September 1, 2013 (Session Law 2013-200. s. 1), requires that at the time the bond order is introduced, the finance officer (or some other officer designated by the governing board for this purpose) shall file with the clerk a statement of the finance officer estimating the total amount of interest that will be paid on the bonds over the expected term of the bonds, if issued, and a summary of the assumptions upon which the estimate is based. The statement shall include a statement to the effect that the amount estimated is preliminary and is for general informational purposes only, that there is no assurance that the assumptions upon which the estimate is based will occur, that the occurrence of certain of the assumptions is beyond the control of the unit, and that differences between the actual circumstances at the time the bonds are issued from the assumptions included in the estimate could result in significant differences between the estimated interest and the actual interest on the bonds. The statement may include other qualifications as the finance officer deems appropriate. The validity of the bonds authorized by the order is not subject to challenge on the grounds that the actual interest cost of the bonds when issued is different than the amount set forth in the statement. The statement shall be filed with the Local Government Commission and maintained by the clerk.

This requirement is the responsibility of each local government unit. Each unit should consult its attorney or bond counsel for legal advice on complying with the requirements of this new statute.

GENERAL

The Local Government Bond Act (Article 4 of Chapter 159 of the General Statutes) states those purposes for which general obligation bonds may be issued and sets forth procedures to be followed in authorizing and issuing bonds. Employment of bond counsel is necessary so that bonds or bond anticipation notes can be marketed. Bond counsel will provide drafts of the various notices, bond order, and other proceedings, and furnish a calendar to be followed throughout all the proceedings. The list of documents (LGC-107) to be filed with the Local Government Commission sets forth the principal steps to be taken in authorizing and issuing bonds and can be used in developing a calendar in conjunction with bond counsel.

BUSINESS ETHICS

To maintain and broaden public confidence, public officials should actively avoid the appearance of, or the fact, of conflicting interests. Public officials should not receive personal gains from their positions, either directly or indirectly, other than normal agreed upon compensation for services rendered in their capacity as public officials. No official should receive or accept any material gifts, services, favors, travel accommodations or other items of personal benefit from engineers, architects, underwriters, attorneys, financial advisors, or other consultants concerned with this financing and the related projects.

PRE-FILING OR PRELIMINARY CONFERENCE

The Secretary of the Commission may require the governing body or its representative to attend a preliminary conference to consider the proposed bond issue before any of the proceedings are begun or the application filed. This is not necessary in all cases; however, a determination should be made as to whether a conference is required. A conference is useful both to the unit of government and to the Commission to resolve questions that might arise at a later date and could delay or prevent the authorization or sale of the bonds.

RESOLUTION OF GOVERNING BODY

The governing body should adopt a resolution making necessary findings relating to proposed bonds, authorizing filing of the application with the Commission and designating authorized representative. The resolution is not required by the Local Government Bond Act and such resolution draft will not be furnished by the unit's bond counsel. While not required by the Local Government Bond Act, the Commission feels that filing of the application should take place as a result of deliberation and action of the governing body. The resolution will supplement the application in making findings

relating to the proposed bonds and in designating the unit's representative to file the application and to be the Commission's contact throughout authorization and sale procedures.

APPLICATION

The "Application for Approval of the Issuance of General Obligation Bonds" must be filed with and accepted for submission to the Local Government Commission prior to or at the same time the bond order is introduced by the governing body. If voter approval of the bonds is required, ten days must elapse after publication of the Notice of Intent before the Commission may acknowledge the filing of the application. In evidence of the publication of Notice of Intent, a publisher's affidavit with clipping is required. Only one copy of the application and its attachments is required to be filed with the Commission.

The resolution should:

- 1. Describe the project for which bonds are proposed.
- 2. State facts as to why the project is necessary and expedient.
- 3. State facts as to why the amount of bonds proposed is adequate and not excessive for the proposed purpose.
- 4. State facts supporting a conclusion that debt management policies have been carried out in strict compliance with the law or reasonable assurances have been given that debt management policies will henceforth be carried out.
- 5. State facts supporting a conclusion that budgetary and fiscal management policies have been carried out in compliance with the law or reasonable assurances that compliance with the law will henceforth be carried out.
- 6. State the estimated increase in property tax rate necessary to raise the estimated increase in debt service requirements and state that such increase is not excessive.
- 7. State the estimated increase in consumer rates needed to raise the estimated increase in debt service requirements if the proposed bonds are for utility or other enterprise purposes and state that such increase is not excessive.
- 8. Designate a representative of the unit to file the application for approval of bonds with the Local Government Commission.
- 9. Authorize the representative or the unit's attorney to employ bond counsel to represent the unit in the authorization and issuance of bonds.

AUTHORIZED REPRESENTATIVE

The authorized representative of the unit should be the person charged with the responsibility of filing the application for approval of the bonds on behalf of the governing body and whom the Local Government Commission will contact with regard to any problems arising during authorization and sale of the bonds. The acknowledgment of filing of the application and approval or disapproval of the application by the Commission will be addressed to the authorized representative and upon whose authority the Commission will rely in initiating sale of bonds or bond anticipation notes after the bonds are authorized. The authorized representative need not be the unit's attorney. Should the attorney and the authorized representative be different individuals, a coordination of activities should be established between the two to assure timely action on necessary proceedings.

SWORN STATEMENT OF DEBT AND STATEMENT OF ESTIMATED INTEREST

A Sworn Statement of Debt by the Finance Officer or other designated officer is required after introduction of the bond order and before the public hearing, along with a statement of the Finance Officer estimating the total amount of interest that will be paid on the bonds over the term of the bonds. The attached Form LGC-109 may be used for the Sworn Statement of Debt. Presently LGC has no form for the Statement of Estimated Interest. If bond counsel provides its own forms for the Preliminary and Sworn Statements of Debt those forms should be used in lieu of LGC-109. A copy of the Preliminary Sworn Statement of Debt and the Statement of Estimated Interest should be filed with the application. The Sworn Statement of Debt should be dated and filed after the introduction of the bond order and before the public hearing.

City Manager's Recommendation / Comments

a) Ordinance No. 29-2021 is presented for City Council consideration at this time. If approved this ordinance would appropriate funding for the construction of T Hangar Building #4 at the Shelby Airport in the amount of \$1,363,100. 90% of this funding (\$1,226,790) will come from our annual NPE (Non primary entitlement) funding received from the NC Division of Aviation each year. The remaining 10% (\$136,310) will be split equally between the City and Cleveland County. Although the airport has been a city owned and operated property since the late 1950's the County has for the last 15 or so years contributed ½ of the usual 10% local match required to receive the NPE funding.

As noted in Mr. Yarboro's memo the City currently has a waiting list of 26 aircraft wishing to lease space in the hangar. Only 10 units are available with each renting for \$250-\$275 per month and generating approximately \$30,000 per year for airport operations. Council will recall that it is a City goal to make the airport self sustaining financially. The construction of the first three (3) T Hangars and now a fourth move us closer to meeting that goal.

b) Resolution No. 45-2021 is presented for City Council consideration. If approved this resolution would award the T Hangar and Taxilane construction contract to Quinn Sales, Inc. in the amount of \$1,363,072.18. It is anticipated the project will be complete in first quarter 2022.

It is recommended that Ordinance No. 29-2021 and Resolution No. 45-2021 be adopted and approved at this time.

Background

As the Shelby-Cleveland County Regional Airport has grown in recent years, the demand for hangar space for based aircraft has dramatically increased. In November of 2019, the City completed a construction project that resulted in the construction of three 10-unit T-Hangars (30 total hangar units) and provided grading for an additional 10-unit hangar. All three of the constructed hangars were leased immediately upon completion and there at 26 aircraft on the current waiting list to base at the airport.

The Shelby City Council approved Ordinance No. 10-2021 (attached for reference) allowing for our airport consultant, W.K. Dickson, to design a project that resulted in construction plans for an additional 10-unit T-Hangar building. This project consists of an asphalt taxilane and one 10-unit T-Hangar building on the pre-graded site. The site plan is attached to this memo for reference.

In May 2021 this project was advertised and bids were solicited. A public bid opening was conducted on June 22, 2021, with 3 bids received. A summary of the bids received are as follows:

W.K. Dickson reviewed the bids and provided a certified bid tabulation (attached for reference) establishing Quinn Sales, Inc. as the low bidder. The bid by Quinn Sales, Inc. is as follows:

- Hangar Building (One 10-unit hangar): \$831,276.76
 - o Add insulation per bid: \$6,620.00
 - o Add gutters and down spouts: \$39,490.00
- Total construction contract: \$1,363,072.18

Following the execution of a contract and being issued a written Notice to Proceed, the contractor will have 120 calendar days to complete the project in addition to the procurement time for the hangar (which based on recent conversations is anticipated to be between 4-5 months.

Our annual Non-primary Entitlement (NPE) Funding (\$166,667 per year) will be utilized to reimburse the expenses associated with this project. With the current Grant funds available and the future NPE funding, it is anticipated that this project will be fully reimbursed in less than 6 years. As a reminder, these grants have a 10% local match that is split equally with Cleveland County.

Recommendations

W.K. Dickson has reviewed the bid documents and qualifications of the bidder and recommends award of the construction contract for the T-Hangar and Taxilane Development Project to Quinn Sales, Inc. in the amount of \$1,363,072.18. City staff concurs with this recommendation and has prepared a resolution for the award of this construction contract for City Council consideration.

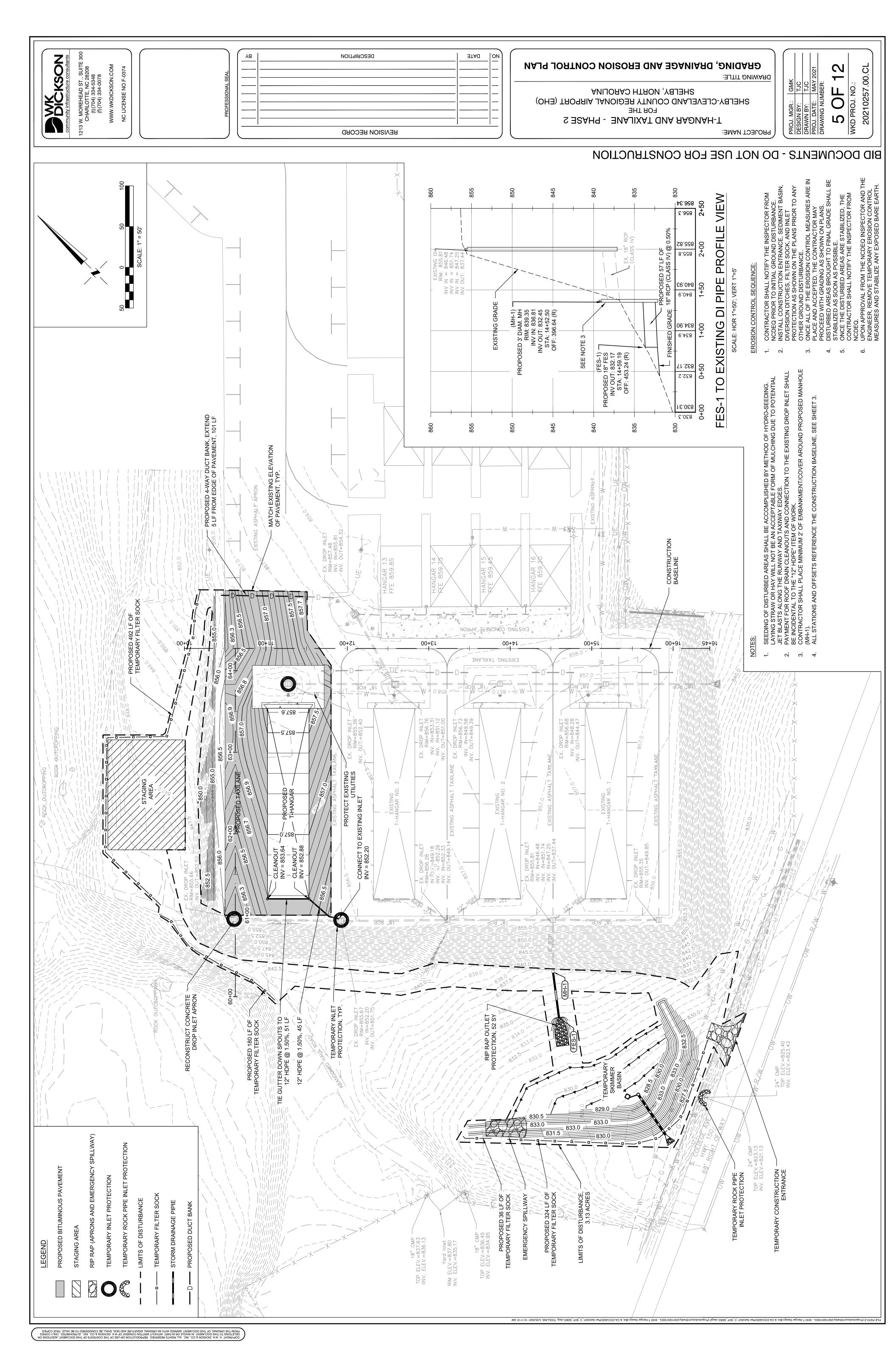

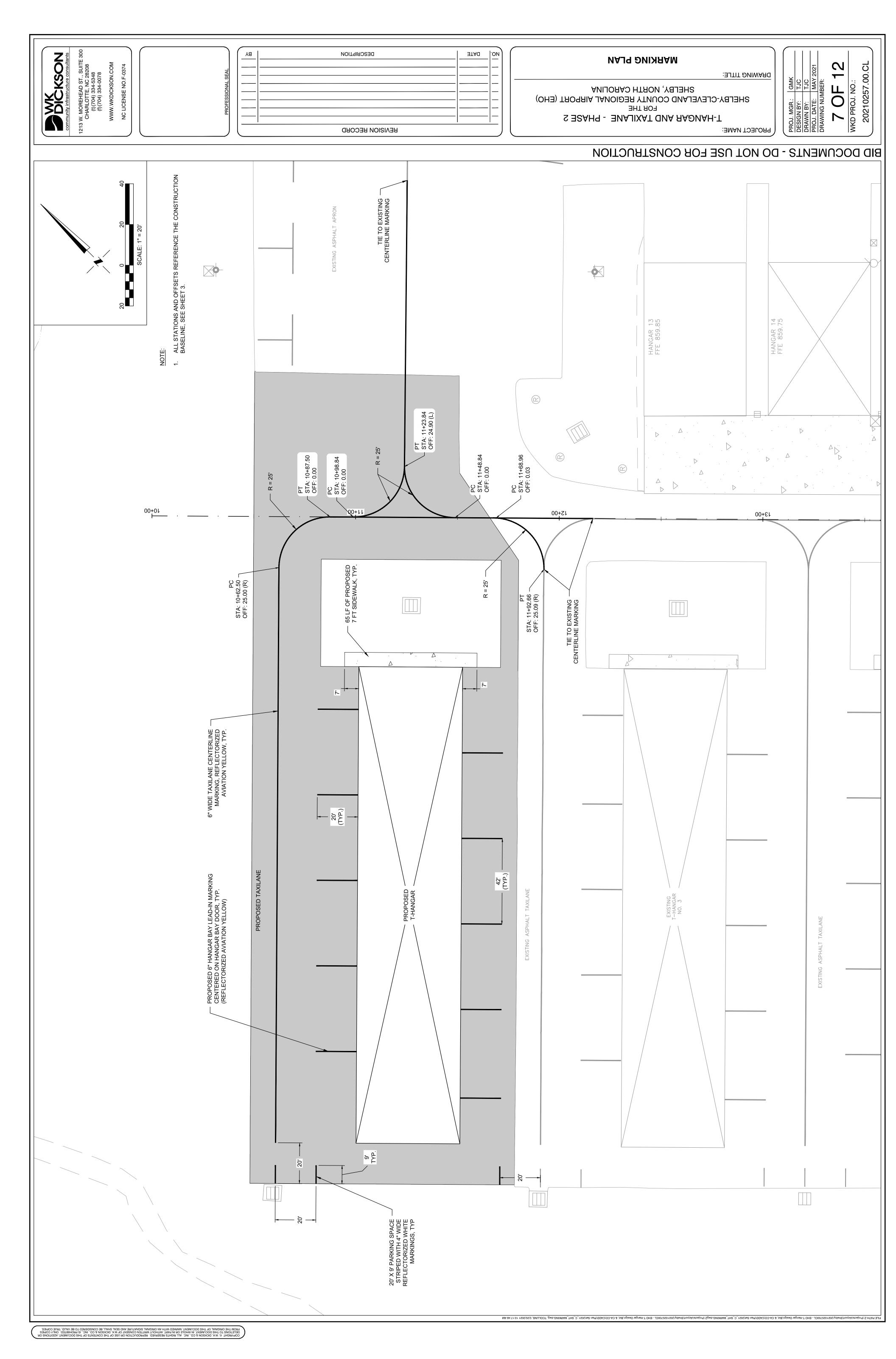

City Manager's Recommendation / Comments

Resolution No. 46-2021 is presented for City Council at this time. If approved this resolution would simply authorize acceptance of funding allocated to the City from the Coronavirus Stated and Local Fiscal Recovery Funds (CSLRF) of HR 1319 the American Rescue Plan Act of 2021. Some specific things to note about these funds. The City will account for these funds in a separate accounting fund along with any accrued investment income. The City is agreeing that it must be spent for the limited purposes spelled out in US Treasury guidance and in accordance with the NC General Statutes and that appropriate reporting for accountability purposes be made as directed. These funds must all be spent or encumbered by December 31, 2024 and completely expended by December 31, 2026 or they must be paid back to the US Treasury.

The City has already received the first payment from the Office of the State Controller in the amount of \$3,191,117.50 and will receive the second half of the money not sooner than one year from now. The total amount expected is \$6,382,235.01. I anticipate placing this on a future Council agenda for discussion in the near future.

It is recommended that Resolution No. 46-2021 be adopted and approved at this time.

FUTHER RESOLVED that the City of Shelby will comply with procedures created by the North Carolina General Assembly and the US Treasury Department to receive funds under the act; and

FURTHER RESOLVED that the City of Shelby will account for CSLRF in a separate fund and not co-mingle it with other revenues for accounting purposes and will comply with all applicable federal and state budgeting, accounting, contracting, reporting, and other compliance requirements for CSLRF funds; and

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Shelby designates and directs the City Manager to take all actions necessary on behalf of the City Council to receive the CSLRF funds.

Background

The Montrose Drive and Windsor Drive area (map attached) natural gas lines are in need of replacement. During the recent system study conducted by RK&K, they identified this area as one with insufficient cover, meaning the depth of the gas pipeline is shallower than code requires. Also, we have found and repaired leaks in the area in the last few years and recently found one that will be repaired as part of this project. The gas line in the creek crossing is exposed and this steel natural gas pipe was installed in 1955.

The project is not a large project, approximately 2,800' of 2" main and 2,560' of 3" services (replacing 16 steel services and tying in 18 plastic services) and has some difficult areas, creek and steep terrain. There is also the indication of rock in the area based on the creek bed. The time frame for completion of the project is small as well, due to street resurfacing of these streets in the last quarter of this year.

The engineering estimate was \$189,220 for the construction portion of the project. Bids were received on Friday, July 2, 2021. Seven contractors were invited to submit proposals. Three bid packages were submitted, one bid package was a no bid. The lowest bid received was \$304,960. The construction time window, gas contractor workload, trouble getting and retaining labor in the current economic environment,

and the difficulty of the creek crossing are all potential factors in the cost of this project.

The bids received were:

Appling Boring Company \$ 304,960 Dawn Development Company, Inc \$ 386,300

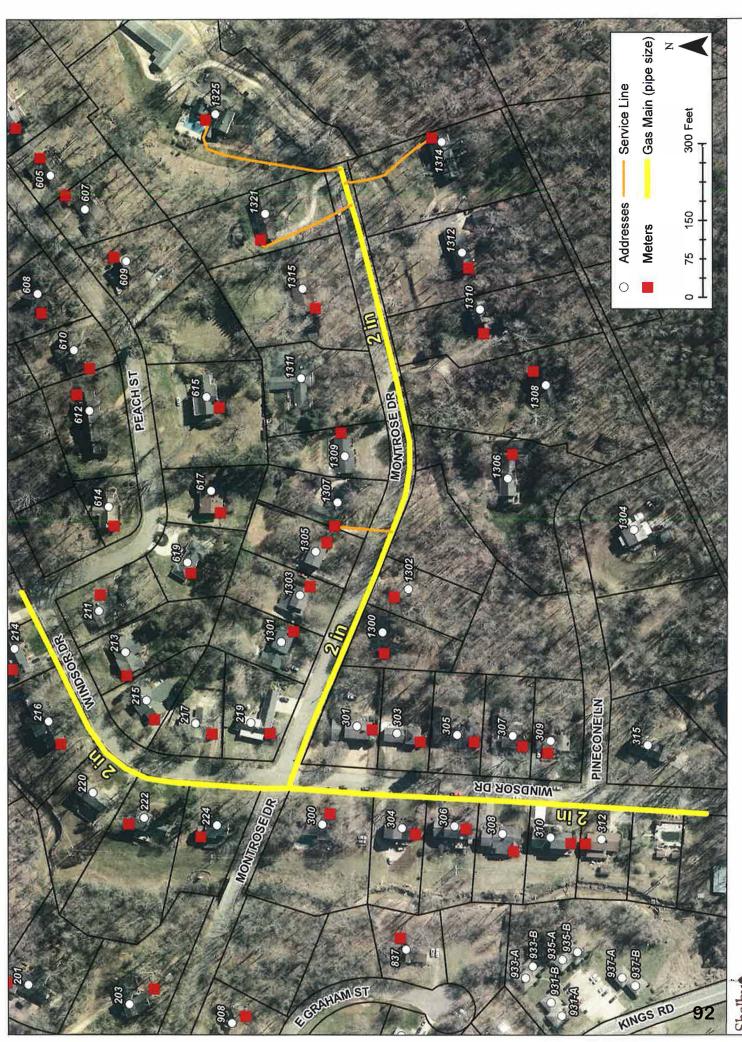
Recommendation

Bid proposals for the City of Shelby's Montrose/Windsor Replacement Project were received on July 2, 2021 at the City's Operations Office from contractors. Seven contractors were invited to submit proposals. There were a total of three bid packages submitted. One of the bid packages was a no bid statement.

Appling Boring submitted the lowest bid of \$304,960.00. Dawn Development has the next lowest bid at \$386,300.00. Attached is the bid tabulation from the proposals submitted. Heath and Associates' estimate for the project was \$189,220.00.

This project is small and has some very difficult areas requiring new pipelines. The requested construction time window was immediate and short in order to complete this project before the scheduled paving of these roads. Natural gas contractors are very busy and experiencing trouble getting and retaining labor in the current economic environment. Most of the contractors didn't want to look at the job because they are overcommitted with existing work, especially given their trouble with laborers. The labor crunch added with the areas requiring difficult construction produced unusually high bid prices.

The contractors that previewed the job were also concerned about the creek crossing. I think the City should investigate alternate ways to cross the creek. Given our short time requirements, we didn't think we could obtain a permit to open cut the creek. A better location to cross the creek may be available but this may require a private easement which also takes time. We may also want to investigate hanging the pipe on the bridge or an aerial crossing. None of the options are particularly attractive, but I am confident we can come up with a means to get better pricing for the crossing.

Heath and Associates recommends that the City investigate the alternate creek crossing designs and rebid the project in the spring of next year. Hopefully, the contractors will have a more stable work force and have less commitments then. We could provide a longer window for contractors to do the work so they could schedule to do the work in a more efficient way. I'm confident we can improve the pricing, probably significantly.

If you want to do the project in the planned timeframe, we believe that Appling's pricing is as good as you can get and would recommend moving forward with them. Appling Boring has a good history working with Heath and Associates and we expect will perform the work professionally and to your satisfaction if you want to do the project immediately.
