Background

The National Fire Academy (NFA) is a department within the United States Fire Administration (USFA) under the direction or the US Department of Homeland Security. The mission of the USFA is to support and strengthen fire and emergency medical services and stakeholders to prepare for, prevent, mitigate, and respond to all types of hazards. Programs and coursework at the NFA are designed to enhance the profession and expand the knowledge and skills of fire and emergency services personnel. The Executive Fire Officer Program (EFOP) is the capstone program at the NFA and highlights the USFA's mission by preparing and engaging senior level officers to meet the ever-changing demands in their communities.

Review

The Executive Fire Officer Program is a rigorous curriculum consisting of two upper division baccalaureate courses and two graduate courses taken over a four-year period at the National Fire Academy's campus located in Emmitsburg, MD. Major coursework is designed to prepare current and aspiring leaders in the areas of executive development and leadership, community education and risk reduction, and emergency management, planning and mitigation. In addition to the residency coursework, students complete peer reviewed applied research projects related to each year's course and defend their fourth-year project before an expert panel at the NFA.

Assistant Chief David Vanhoy completed the required coursework and successfully defended his capstone research project and was conferred graduation from the executive fire officer program on April 15, 2022. It is important to note that Chief Vanhoy's studies were marked with adversity related to the COVID-19 pandemic with delays in residency course offerings, modifications to instruction, and restrictions in the on-campus experience.

Recommendation

With his recent graduation, Chief Vanhoy joins an elite cadre of fire service leaders from across the profession that have earned the executive fire officer designation from the NFA. Merritt, MPA, Assistant City Manager Benjamin (Ben) Yarboro, City Clerk Carol Williams, Deputy City Clerk Breanna Jones, Public Information and Communications Officer Chip Nuhrah, Director of Human Resources Deborah (Deb) Jolly, Director of Finance Elizabeth (Beth) Beam, CPA, Police Chief Jeffrey (Jeff) Ledford, Fire Chief William Hunt, EFO, Planning and Development Services Director Walter Scharer, and Jennipher H. Harrill, Social Media Manager, Blue Eyes Media Connections;

Mayor Anthony called the meeting to order at 6:00 p.m. recognizing Boy Scout Troop 101 from First Baptist Church.

Mayor Anthony delivered the invocation and invited the Boy Scout troop to lead the Pledge of Allegiance.

A. Approval of agenda:

1) Motion to adopt the proposed agenda

Mayor Anthony requested the removal of Item B-1 under Special Presentations due to a scheduling conflict, and Item E-2(b) under Consent Items be removed from tonight's agenda.

ACTION TAKEN: Upon a motion by Mr. Causby, City Council voted unanimously to approve the agenda as amended.

Ms. Arth requested permission to excuse herself from the City Council meeting by 7:10 p.m.

ACTION TAKEN: Upon a motion by Mr. White, City Council voted unanimously to approve Ms. Arth permission to leave early.

B. Special Presentation:

1) Recognition of Director of Finance, Beth B. Beam, and the City of Shelby's Finance Department as recipients of the Certificate of Achievement for

Excellence in Financial Reporting awarded by the Government Finance Officers Association for Fiscal Year ended June 30, 2021.

Mayor Anthony recognized the City's Finance Department for attaining this award for over 15 years. Mayor Anthony presented the award certificate to Beth Beam, Finance Director, for the City of Shelby. Mrs. Beam acknowledged it was with great teamwork that this award is possible. Mrs. Beam further indicated that she was glad to lead such a great team and would extend the Council's appreciation to the Finance Department.

C. Public Comment:

- 1) Mary Degree who resides at 1110 Stanton Drive, Shelby, North Carolina presented to Council a petition signed by homeowners in her neighborhood who are against a duplex being built on a vacant lot on Stanton Drive. Mrs. Degree also presented the Restrictions that are recorded in the Register of Deeds (Book 7, Page 88) pertaining to this neighborhood. Mrs. Degree stated she and her neighbors are not against building homes, but against a duplex being built. Mrs. Degree read the Restrictions to Council which in her opinion applied to this matter.
- 2) Richard Hooker who resides at 1520 King Arthur Court, Shelby, North Carolina spoke about Minority Enterprise Development Week, October 23rd 29th, 2022. Mr. Hooker stated this would be the 30th year of the Development Center being in Cleveland County and the City of Shelby. Mr. Hooker further stated this year's theme is Enduring Legacy and Sustainability which will recognize the longevity of this organization. Mr. Hooker recognized the support this organization has received from City Council and invited them to attend the celebration this year.
- 3) Marcus Cyprian who resides at 1111 Stanton Drive, North Carolina echoed Mrs. Degree's concerns about the building of the duplex next door to his mother's home. Mr. Cyprian stated this is an older neighborhood but one that cares about each other and wants things done the right way. Mr. Cyprian thanked Council for their time.
- 4) Reverend James L. Smith who resides at 1100 Hemlock Drive, Shelby, North Carolina stated the community at Sherwood Acres is made up of hard-working people and he has lived there since 1984. Rev. Smith asked Council if something can be done about the large hole in the ground at the vacant lot on Stanton Drive; he said it is a mess when a large rainfall happens. Reverend Smith concluded by stating this is the City of Pleasant Living and it should be that in all communities not just some communities.

Mayor Anthony appreciated the comments and reminded the neighborhood group that deed restrictions cannot be enforced by the City but can be enforced through the court system. Mayor Anthony stated there may be grounds for legal action against the property owner but that would be up to the neighborhood and an attorney to consider. Mayor Anthony concluded by stating Mr. Scharer has contacted the property owner and instructed the owner to fill in the hole.

D. Public Hearings:

1) Consideration of a proposed ordinance amending the zoning map of the City of Shelby, North Carolina (2043 Green Oak Drive): Ordinance No. 50-2022

Mr. Scharer introduced a zoning map amendment for property located at 2043 Green Oak Drive from R20 zoning district to R6-CZ zoning district. Mr. Scharer stated sewer is available in this area. Mr. Scharer stated the applicant included the conditional use amendment with a condition of only allowing single family dwellings on this site. Mr. Scharer said the applicant, Ashley Jennings, wishes to build two single-family dwellings on this property, with each lot being approximately 7,500 square feet.

Mr. Scharer shared that the homes in this neighborhood are approximately 1200 square feet and reminded Council that the City cannot restrict home sizes but can regulate lot size. Mr. Scharer stated the applicant has plans for each home to be approximately 1800 square feet.

Mr. Howell reminded Council that the size of the home is immaterial, only the lot size being proposed should be considered.

Mr. Scharer stated that the amendment is inconsistent with the Shelby Comprehensive Land Use, and that the Planning and Zoning Board had a split vote (4-3) to deny the zoning amendment.

Mayor Anthony opened the public hearing at 6:26 p.m. and invited comments from the public.

Ashley Jennings, property owner of 2043 Green Oak Drive, Shelby, North Carolina spoke as the applicant and in favor of the rezoning amendment. Ms. Jennings stated she is from Cleveland County and her father lives in the Green Oak Drive neighborhood. Ms. Jennings stated as a developer she focuses on distressed properties and renovates them for new ownership. Ms. Jennings declared her company, Experience Capital, LLC has revitalized 11 homes this year, brought \$6 million into the housing market, and has sold 75 homes. Ms. Jennings presented to Council a few examples of the homes her company has been involved with this year, and stated she uses several local

companies and tradesmen for plumbing, electrical, drywall, paint, flooring, etc.

Ms. Jennings further stated she wants to build two homes because housing at this price point is needed. Ms. Jennings said that if we continue to stay the same then nothing is going to change, and the City becomes stagnant.

Ms. Jennings stated she and Mr. Scharer talked about options for this property and she's glad she didn't choose to do a duplex; however, she decided to do two single-family homes to keep with the community the same.

Mayor Anthony closed the public hearing at 6:34 p.m.

Mayor Anthony reminded Council in this matter there needs to be a statement of reasonableness in the motion.

Mr. Scharer came forward to state that he neglected to tell Council earlier that this matter could be a potential spot zoning issue that a Judge could overturn if this zoning amendment was challenged.

Mr. Howell stated if this rezoning makes sense, then Council may want to look at the neighborhood to see if it makes sense to rezone the entire development. Mr. Howell also acknowledged that the City should make sure utilities support the additional density.

ACTION TAKEN: Upon a motion made by Mr. White, City Council voted 3 – 3 (Bullock, White, Causby – Arth, Webber, Hopper) to deny Ordinance No. 50-2022 entitled, "A PROPOSED ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF SHELBY, NORTH CAROLINA (2043 GREEN OAK DRIVE)" based on the inconsistency statement in Section 1 and the unreasonableness statement in Section 2 of the Ordinance. Mayor Anthony casted a tie-breaking vote against Mr. White's motion to deny.

ACTION TAKEN: Upon a motion made by Mr. Hopper, City Council voted 4 – 2 (Arth, Webber, Hopper, Causby – Bullock, White) to approve and adopt Ordinance No. 50-2022 entitled, "A PROPOSED ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF SHELBY, NORTH CAROLINA (2043 GREEN OAK DRIVE)".

2) Consideration of a proposed ordinance amending the zoning map of the City of Shelby, North Carolina (Lithia Springs Road): Ordinance No. 51-2022

Mr. Scharer introduced a zoning map amendment for property located on Lithia Springs Road from R20 zoning district to R6 zoning district. Mr. Scharer stated that the property is currently vacant, and that sewer is available in the area. Mr.

Scharer declared that an R6 zoning can be for single family dwellings or multifamily dwellings and a Special Use Permit would not be required.

Mr. Scharer also pointed out that the future land use for this area is listed as Conservation Development because at the time the exact path of the new bypass was unknown and there was no sewer available; now we know the path of the by-pass and there is sewer available.

Mayor Anthony opened the public hearing at 6:52 p.m. and invited comments from the public. There were no comments from the public.

Mayor Anthony closed the public hearing at 6:53 p.m.

ACTION TAKEN: Upon a motion made by Ms. Arth, City Council voted unanimously to approve and adopt Ordinance No. 51-2022 entitled, "A PROPOSED ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF SHELBY, NORTH CAROLINA (LITHIA SPRINGS ROAD)" based on the consistency statement in Section 1 and the reasonableness statement in Section 2 of the Ordinance.



City Manager's Recommendation / Comments

Resolution No. 64-2022 is presented for City Council consideration at this time. If approved this resolution would formalize the interim appointment of Teague, Campbell, Dennis and Gorham, LLP to serve in the capacity of City Attorney. This resolution satisfies the requirement of NC General Statute 160A-173 for Council to appoint a City Attorney to serve at its pleasure and to as its legal advisor.

I have found the firm to be well experienced and capable of serving the City's legal needs in the interim. Their current slate of clients demonstrates a knowledge of municipal law and reference checks verified their experience. Natalia Isenberg will be our principal contact with Teague Campbell.

HOURLY REPRESENTATION AGREEMENT

The terms of this Agreement, by and between the City of Shelby (hereinafter referred to as "Client") and Teague Campbell Dennis & Gorham, LLP (hereinafter referred to as "Law Firm"), are set forth as follows:
