MINUTES

Regular Meeting

Mayor Anthony called the meeting to order at 6:00 p.m. and delivered the invocation.

Mr. Causby led the Pledge of Allegiance.

A. Approval of agenda:

1) Motion to adopt the proposed agenda as presented.

ACTION TAKEN: Upon a motion by Mr. White, City Council voted unanimously to approve the agenda as presented.

B. Special Presentation:

1) Recognition of Jeffrey Harold Ledford on the occasion of his retirement from employment with the City of Shelby: Resolution No. 20-2023

Mayor Anthony called upon Jeff Ledford and formally read and presented framed Resolution No. 20-2023 to Mr. Ledford. He then presented a custom shadowbox in honor of and with heartfelt appreciation for his 30+ years of dedicated service to the City of Shelby.

Humbled by the recognition, Jeff Ledford recognized his wife and Shelby Police Department staff in attendance. Mr. Ledford thanked City Council for their support over the years, and stated this has been a career of a lifetime. Mr.

Ledford stated he's sworn in many people, and he tells them that they are joining 110 of the best law enforcement in the business; and joining 340 of the best employees within the City of Shelby. Mr. Ledford further stated that the City of Shelby is unique because of the way all the departments work so well together. In closing, Mr. Ledford thanked everyone again and he appreciates everyone he's gotten to work with.

Mr. Howell stated that he knew when he was tasked with appointing a new Chief of Police in 2008 that he had the new chief in house. Mr. Howell stated there was a significant hiring process with qualified people, but Mr. Ledford earned his Chief appointment. Mr. Howell stated he knew right away that he had made the correct decision in promoting Mr. Ledford; stating it has been a joy to work with him. Mr. Howell considers Mr. Ledford a friend and an ultimate team player; he will miss him professionally and personally.

In a surprise addition to the meeting, at the Mayor's discretion, Mr. Howell presented outgoing Assistant City Manager Justin Merritt with a framed key to the City. Mr. Howell stated Mr. Merritt has been with the City since 2012; and he is a workhorse that makes things happen. Mr. Howell further stated Mr. Merritt is very humble, not worried about getting credit, and wants to get the job done. Mr. Howell stated he's sad to see Mr. Merritt leave but is really proud of where he's going. Mr. Howell thanked the Mayor and Council for indulging him to make this presentation.

Humbled by the recognition, Mr. Merritt stated that the team he's worked with, and the entire Shelby community has been a very special place for him; and he thanked everyone for their support and this recognition.

C. Public Comment:

Phyllis Williams who resides at 1030-3 Sue Lane, Shelby, North Carolina addressed Council about the lack of adequate affordable housing in Shelby. Ms. Williams presented statistics about the number of people and the demographics of people/families waiting to obtain housing. Ms. Williams stated a home is essential, but far too many families are disrupted because housing is out of reach in Cleveland County. Ms. Williams concluded by stating it is time for a transformative housing agenda.

Jamie Coulter who resides at 401 Edgewood Road, Shelby, North Carolina came on behalf of the Cleveland County Music Hall of Fame. Mr. Coulter stated they plan to host an event on September 23^{rd,} and he asked for direction on how to go about obtaining a Special Event permit. Mayor Anthony instructed Mr. Coulter to contact the City Clerk for the necessary paperwork.

Mayor Anthony presented the consent agenda. Ms. Arth moved to approve the consent agenda and the following items were unanimously adopted:

F. New Business

1) Approval of a resolution awarding the contract for the Substation 10 Copper line Reconductoring Project: Resolution No. 24-2023

Mr. Howell introduced this resolution and if approved would award a contract to Southeastern T&D in the amount of \$358,044.96 for construction of this project. Mr. Howell reminded Council that in 2016 a 5-year Electric System Planning Study was developed; and this is one of the projects that was identified. Due to COVID some work has been slowed but the City is now ready to proceed. Mr. Howell concluded by stating this project would replace a significant amount of the old brittle copper wiring in the system.

ACTION TAKEN: Upon a motion by Mr. Hopper, City Council voted unanimously to adopt Resolution No. 24-2023 entitled, "A RESOLUTION AWARDING THE CONTRACT FOR THE SUBSTATION 10 COPPER LINE RECONDUCTORING PROJECT."

- 2) Consideration of appointments to City advisory boards and commissions:
 - a) Housing and Redevelopment Board

Mayor Anthony reported the terms of three incumbents, Keith Hawkins, Sharon Leigh, and Tanzy Wallace, concluded March 2023. Mr. Hawkins wishes to step down; Ms. Leigh and Ms. Wallace wish to continue their service.

ACTION TAKEN: Upon a motion by Mr. Webber, City Council voted unanimously to close the nominations and accept the nominees by acclamation."

G. City Manager's Report

- Regarding the City Hall Roof replacement project: It is obviously ongoing, and the slate will be installed as early as tomorrow morning.
- Regarding the Aquatics Center project: It is moving along with a turnover date of May 15th so staff can start filling the pool and getting ready for the Memorial Day weekend opening.
- Regarding Phase 1 of the Rail Trail: It is moving along with a completion date pushed back to mid to late July, 2023.

H. Council Announcements and Remarks:

Mayor Anthony reminded Council of the NCLM CityVision conference next week in Concord, NC. Mayor Anthony suggested that Mr. Howell send out a proposed agenda for the events that Council is interested in.

Mayor Anthony asked Mr. Howell about the Budget Workshops. Mr. Howell requested they be postponed to possibly the first or second week of May.

Mayor Anthony announced there is a Litter Sweep this Saturday, April 22nd on Gidney Street, meet at the warehouse.

Mayor Anthony stated the Merry Go Round festival awards banquet is Thursday, April 27th at 6:15pm at the Don Gibson Theater.

Each of the Council members addressed their appreciation to former Chief Jeff Ledford and Assistant City Manager Justin Merritt, and that they will be missed.

Ms. Bullock also announced the Shelby-Cleveland County Regional Airport Fly-In is scheduled for June 10, 2023.
