Mayor pro tem Hopper called the meeting to order at 6:00 p.m. and Mr. Webber delivered the invocation.

Mrs. Bullock led the Pledge of Allegiance.

Fee Schedule. Mr. Howell reminded Council that after the public hearing tonight they can act on the Budget Ordinance and the Supplemental Budget Ordinance. Mr. Howell stated the budget needs to be adopted by June 30, 2023.

Mayor pro tem Hopper opened the public hearing at 6:05 p.m. and the public offered no comments.

Mayor pro tem Hopper closed the public hearing at 6:06 p.m.

F. City Manager's Report

Mr. Howell updated Council on the following projects:

City Hall Roof Project:

A substantial portion of the roof replacement project is complete. The slate portion and the cupola construction are complete. The gutters, downspouts and the flat roof portions of the building need to be finished. This project has gone well, and Mr. Howell appreciates the staff and citizens for being patient when we've had to close certain entrances to get work done.

Opportunity Appalachia Grant update:

The City received a grant for the Hotel Charles project through Opportunity Appalachia. Part of this grant allowed the City to do an online pitch session for potential investors. Former Assistant City Manager Justin Merritt handled this for the City since Mr. Howell was out of town. We've already had some interest in the project. Mr. Howell thanked Mr. Merritt for representing the City very well and for his willingness to assist the City with this portion of the project. Mr. Howell stated the due diligence continues and a feasibility report and market analysis study will be completed in the next couple of months.

Proposed Bills going through the General Assembly:

Mr. Howell stated there are a couple of bills that could be damaging to local governments. Some bills take control out of local hands, for example, ETJ and other land use decisions. Mr. Howell stated we need to work with the League of Municipalities and members of the General Assembly to provide information to them and share our thoughts on the proposed bills. Mr. Howell explained the history of ETJ (extra-territorial jurisdiction) and the good and bad issues with having an ETJ.

G. Council Announcements and Remarks:

Mr. White commended Mr. Howell and the staff for the new slate roof. Mr. White stated he has received many comments about how great the roof looks.

Ms. Arth congratulated Kristen Reese from Cleveland County Economic Development Partnership on her retirement. Ms. Arth stated Mrs. Reese was instrumental in bringing many industries and jobs to our area. She will be hard to replace.

Mr. Webber said kudos to the Burns High School Baseball team and Coach Alex Leonhardt for winning the State 2A Championship this past weekend. Mr. Webber continued by stating this is the first baseball State championship for Burns High School.

H. Closed Session:

The motion passed unanimously, and Council moved into closed session at 6:20 p.m.
